At the outset the Mayor of Clonmel, Cllr. Michael Murphy offered his condolences to the family of the late Mr. Sean Nyhan, former Mayor of Clonmel.

The Mayor of Clonmel noted some opening remarks before the agenda. He thanked the members of the St. Patrick's Day Parade Committee for organising this year's Parade which will be very much welcomed in the community. Mr. Danny Carroll, known locally as "Mr Music Man" will be the grand marshal of the parade 2022.

The Mayor thanked the emergency services in relation to how they dealt with the recent fire at the former Clonmel Arms Hotel building. He noted that on Friday the 11<sup>th</sup> March, 2022 there will be a Mayoral Reception at 2pm for the National ICA association.

Cllr. Siobhán Ambrose thanked the Taoiseach, Mr. Micheál Martin who visited the South Tipperary University Hospital recently on her request. The additional funding recently announced is fantastic news for the Hospital. She also noted that the recent approval of an extension to the Waterford Airport was a game changer in the south east and asked that this should strengthen our case for the N24 bypass so desperately needed in the area.

Cllr. Richie Molloy also welcomed the additional funding for the hospital in Clonmel but said that we need to keep pushing for additional psychiatric services.

# Item 1.1 Disclosures and/or Conflicts of Interest

Mr. Jim Dillon, District Administrator confirmed that there were no conflicts of interest disclosed.

# Item 2.1 Minutes of Meeting held on 19th January, 2022

The minutes of the monthly meeting of Clonmel Borough District held on the 19<sup>th</sup> January, 2022, as presented, were proposed by Cllr. Siobhán Ambrose, seconded by Cllr. Pat English, and agreed.

## Matters arising:

- Cllr. Niall Dennehy asked if there was any update on the list of guidelines that he requested from the Department in relation to Covid at the last district meeting.
- Cllr. Niall Dennehy asked if there is any update from NAMA in relation to what funds benefited the Clonmel Borough District, their 2021 disclosures show that Dublin did very well from distribution of NAMA assets. Public private partnership could be set up to utilise these funds in our area.
- Cllr. Pat English asked was there any update on the next call for URDF funding and what are the timelines?
- Cllr. Pat English stated that Tipperary Studies have taken charge of the Clonmel Graveyard online service which is a great initiative set up by Mr. Eamon Crowley, what is the current situation?
- Cllr. Pat English ask if there was any update on the N24, can we write to the Minister on this?
- Cllr Siobhán Ambrose asked in relation to the digital hubs with various uses, any update now that we have received the funding when tenders will go out?

#### Response made as follows;

- Mr. Jim Dillon, District Administrator asked Cllr. Niall Dennehy to contact him after the meeting for clarity on what he is looking for in relation to Guidelines issued from Department during Covid.
- There is no response from NAMA in relation to Cllr. Niall Dennehy's query on Clonmel Borough District assets.
- No update since last district meeting in relation to information that call for next round of URDF should happen in Q2 of 2022. Ms.
   Sinead Carr confirmed that the Department has re-prioritised the criteria in the process and will be done in the context of town centre first.
- Mr. Damien Dullaghan, County Librarian is to update on the Tipperary Studies involvement with the online initiative for Burial Ground records.
- The District Administrator will draft a letter to the Minister in relation to the N24 and the announcement that we have been taken out of the plans.

 In relation to the Digital Hub, Clonmel Business Park Limited are in the process of developing specifications for tenders and no other update. A feasibility study will be carried out with the first round of funding.

# The following queries were raised to the briefing note by members:

- Cllr. Michael Murphy asked if there would be a return to physical planning meeting and that the system of slots available for Members be made available again?
- All members asked what the position in relation to the 6Km corridor of land that is currently a no-go zone for planning currently in relation to the N24 which was recently shelved by the Department?

#### Members' queries were addressed as follows:

- Ms. Caroline Conway confirmed that the return to physical meetings will happen towards the end of March and this will be part of a hybrid model to allow for both physical and zoom meetings whichever was preferable by the customer. The return to slots for Members will also continue as normal.
- The planning section understand the frustration of the customers in relation to the planning restrictions in the 6km area in relation to the N24. The planning section will continue to liaise with the TII, Roads Capital team and the Regional Design office.
- Members thanked the planning section for continued engagement and progress being carried out in relation to the taking in charge of estates in the Clonmel Borough District.

The Mayor thanked Ms. Caroline Conway, Senior Executive Planner, Mr. Jonathan Flood, District Planner and Mr. Kieran Ladden, Senior Executive Engineer for their attendance and report.

# <u>Item 4.2 Attendance of Representatives from Directorate Water</u> <u>Services</u>

Mr. John Crowley, Executive Engineer and Mr. Pat Holland, Administrative Officer referred to a district briefing note circulated to Members with the agenda detailing key issues relating to the Water Services Directorate.

## Key issues in the briefing note included:

# The following queries were raised to the briefing note by members:

- Members stated their disappointment in the recent outages of water in Clonmel which has happened continuously over the last two weekends. Members are feeling the frustration and anger of the local businesses and residence in relation to the unreliability of the system. Members stated that this service was simply not good enough.
- Members also relayed their own frustration that the Irish Water customer line for outages is only operational Monday to Friday and no service at the weekend.
- Members outlined the seriousness of the situation, it was noted that
  this isn't a recent issue this serious issue has been going on for
  years and has been raised at Plenary level. Substantial investment
  will have to take place in water infrastructure in the town of
  Clonmel. The system currently providing water is not fit for
  purpose. Members agreed that a meeting with senior officials of
  Irish Water should be called.
- Cllr. Ambrose asked for an update on water outages in Kilcash village and what are the long-term plans for Kilcash?
- What is the current position in relation to Kilsheelan village upgrade works?
- Cllr. Ambrose and Cllr. Murphy raised the issue of poor water pressure in areas in Clonmel and asked if there was any solution to same?
- Cllr. Michael Murphy stated that both himself and Cllr. John
   Fitzgerald will be meeting the Tánaiste, Mr. Leo Veradka on a one to

one basis, and that he will most definitely bring up the issue of the need for serious investment in the water infrastructure of the town.

## Members' queries were addressed as follows:

• Mr. John Crowley address the members and stated that they were in continuous talks with Irish Water in relation the infrastructure in the town and the need for heavy investment in the town.

The Mayor thanked Mr. John Crowley, Senior Executive Engineer and Mr. Pat Holland, Administrative Officer for their attendance and report.

## Item 5.1 Report of District Administrator

The District Administrator's report was circulated to Members with the agenda.

# Queries raised by the members were as follows;

- Cllr. Siobhán Ambrose ask in light of recent news relating to paying for parking in hospitals by credit card could this system be brought in to the town of Clonmel on the streets?
- Cllr. Niall Dennehy asked if the new parking charges that came into effect recently had affect our own process in the town of Clonmel?
- Cllr. Niall Dennehy enquired in to the issue of lack of community bus service and could the District Administrator look in to this?
- Cllr. Niall Dennehy asked if their could be a sombre service held after the St. Patrick's Day festivities to commemorate the closing of the Army Barracks on Kickham Street which closed on 26<sup>th</sup> March, 2012. No other member was in support of this initiative.
- Cllr. Pat English asked if there was an update on the town centre first programme?
- Cllr. Pat English asked what the update was in relation to outdoor performance areas such as the plan for Abbey Street Car Park?
- Cllr. Pat English asked if there could be a briefing on the tree strategy for the district?
- All members acknowledged the great work being done in the town of Clonmel in relation to street cleaning and in particular cleaning chewing gum from the footpaths.
- Cllr. Michael Murphy asked for a standing orders meeting to be conveyed in relation to the erection of a plaque at Kickham Barracks.

# Queries raised by the Members which Mr. Jim Dillon, District Administrator responded to were as follows;

- The issue of on street pay parking by credit card is a matter that
  was raised at a recent meeting with the Director of Roads and this
  something that they hope to progress in to the near future if
  feasible.
- The only update to the parking fines nationally which effect Clonmel are parking on bus lanes, cycleway or footpaths. It doesn't relate to

- any other fine. There isn't a huge issue in relation to this in Clonmel so hasn't affected our overall revenue at this stage.
- The outdoor performance area is still under consideration as to what type of design will be put in place. Due regard has to be made in relation to the amount of spaces taken over by the design.
- The District Administrator and Mr. Tim Murphy, Executive Engineer will meet with Ms. Roisin O'Grady, Heritage Office shortly for setting up the parameters for the tree strategy and then will be going out to the wider community for their input on the plan.
- Ms. Sinead Carr, Town Manager stated that she will circulate the document in relation to the town centre first programme to all members. If you require a presentation on same this can be done by the District Administrator at the next District Meeting.
- The District Administrator will organise a Standing Orders Committee meeting as requested within the next week.
- The District Administrator will follow up on the local bus service.

## Item 5.2 Report of District Engineer – Roads Programme

The District Engineer's report was circulated to Members with the agenda. **Queries raised by the Members were as follows:** 

- Cllr Pat English asked for an up date on the pedestrian crossing on the Davis Road?
- Members welcomed the speed cushions now installed on the Marlfield road.
- Cllr. Pat English ask if there was an update on the resurfacing works on the Dungarvan road?
- Cllr. Pat English ask if there was an update on Rathronan Cross?
- Cllr. John Fitzgerald asked if Darcy's Cross works will be carried out soon?
- Cllr. John Fitzgerald requested an update on the road issues raised previously in relation to Clerihan National School?
- Cllr. Michael Murphy welcomed the works carried out on the Coleville road, he asked if it was possible to take another speed survey on the road to show the difference the works have made to the area in relation to the survey that was taken prior to works.

# Queries raised by the Members which Mr. Eoin Powell, District Engineer responded to were as follows

- The pedestrian crossing on the Davis road has been looked at and there is a problem with it in terms of parking at that area it will be investigated further.
- The District Engineer agreed that a survey on the Coleville road would be a useful tool to determine the outcomes of the changes made.
- Rathronan cross is on the road works programme and will be carried out this year.
- District Engineer stated that Hopkins Lane lighting is being looked at.

- St. Patrick's Cemetery entrance works will begin in approx. 5 months.
- The District Engineer confirmed that he had looked at the issue of speed ramps in Clerihan by the National School, there is a place that a ramp could go in but he explained that in order to do so the lighting in the area needs to be improved which will make the project more expensive and currently the district would not have a budget for same.

The District Engineer asked if all members were in agreement with the red roads programme. This was proposed by Cllr. Pat English and seconded by Cllr. John Fitzgerald.

# <u> Item 5.3 Report of District Engineer – Housing Voids Programme</u>

The District Engineer's report was circulated to Members with the agenda.

No issues were raised.

# <u>Item 6.1 Chief Executive/Delegation Officers Orders - Period up to 11<sup>th</sup> February, 2022</u>

This item was noted.

# <u>Items 7.1 to 7.9 - Notices of Motions</u> Motion 2350 was proposed by Cllr. Pat English.

That Clonmel Borough District look at providing additional safety measures on the Fethard Road at the dangerous bend between Rathronan Crossroads and the Half Way Bar. This section of Roadway has recorded a number of serious accidents over the last number of years and requires additional crash barriers signage and road markings.

#### Reply:

The District Engineer is familiar with this situation on the ground and recently met with the landowner on site to discuss same. Apart from a fatal accident quite a long time ago, (at a different bend closer to Fethard which had barrier rail installed, I am not aware of a 'number' of serious accidents in the last number of years. In my time in the district since February 2017 there has been two accidents at this location, both in the last 6 to 9 months. The first was a drunk driver, and the other more recent the driver admitted to the Guards on site that they were driving too fast to take the bend.

In late 2022 the Department will be seeking proposals for Low Cost Accident Schemes for 2023, and a proposal can be submitted at that time to see if monies can be made available for this location. In the short term the District Engineer will install additional signs and road markings in 2022 in order to remind drivers to drive more carefully and slowly at this location.

The motion was seconded by Cllr. Siobhán Ambrose. This was agreed by all members.

Motion 2351 was proposed by Cllr. Pat English.

That Clonmel Borough District Council write to the T.I.I. And the Minister to request they look at funding for a roundabout at the Junction of the Haywood Road and the Frank Drohan Inner Relief Road in the interest of Public Safety and the proper flow of traffic.

## Reply:

If the Members agree, I will contact TII in relation to the provision of a roundabout at the junction of Heywood Road/Frank Drohan Inner Relief road.

The motion was seconded by Cllr. Siobhán Ambrose. This was agreed by all members.

## Motion 2352 was proposed by Cllr. Pat English

That Clonmel Borough District Council contact the owners of Jimmy Keating's old shop at Elm Park, Clonmel to see if the property could be used for housing as the property is at present been used for anti-social behaviour and is an eye sore because of its dereliction.

#### Reply:

This site has been included on the Derelict sites register and the Environment section have been liaising with the owner to render the site non-derelict. I have also asked housing section to examine the site to assess its suitability for housing.

The motion was seconded by Cllr. Siobhán Ambrose. The reply to the motion was noted.

#### Motion 2353 was proposed by Cllr. Michael Murphy

Following on from my previous Notice of Motion, that under the 2022 Area Roadworks Programme, consideration is given to the installation of a number of speed ramps in the Dromard Crescent Estate, Clonmel, due to on-going issues with speeding motorists. Residents are extremely concerned around the safety of young children living in the estate. Particular attention should be given to that stretch of road between house numbers 1 to 13.

#### Reply:

The District Engineer inspected this location and has noted that the road configuration is capable of installing a couple of speed cushions. I have received a signed submission from the local residents of twenty houses in this estate in the immediate vicinity of the proposed locations for the ramp. The next step in accordance with the Council's policy is to carry out a speed survey in this estate in order to establish the extent of the speed violations and by how much, and this will be carried out in the next month.

The motion was seconded by Cllr. Siobhán Ambrose The reply to the motion was noted.

Motion 2354 was proposed by Cllr. Michael Murphy

That the Council work carry out works along the footpaths in the Glenconnor area. I refer in particular to that section between the Glenoaks estates and Glenconnor Garden Centre that are in urgent need of attention. Hedges are overgrown and large amounts of growth and clay covering the inside of the paths. Requesting that the hedgecutter, perhaps the sweeper as well, visits this location at the earliest opportunity, indeed any other machinery required as well. Such works crucial for pedestrian safety.

# Reply:

The District Engineer has inspected this footpath on the west side of the Glenconnor Road and has noted that there are three sections of the footpath measuring about 270 metres that require to be cleared of vegetation, etc. This work will be carried out over the next few weeks.

The motion was seconded by Cllr. Siobhán Ambrose. The reply to the motion was noted.

# Motion 2355 was proposed by Cllr. Michael Murphy

Whilst welcoming the new public lighting along the western section of the Clonmel By Pass that were switched on over 12 months ago, I'm calling on the Council to examine the standard of lighting. On the face of it the lighting is poor and many walkers and cyclists have contacted me about the need to improve such lighting, in particular having regard to recent events nationwide.

#### Reply:

As a first step, the District Engineer will carry out a survey of the existing lighting on Clonmel By Pass and if necessary will seek to improve same, dependant on a budget being available.

The motion was seconded by Cllr. Pat English. The reply to the motion was noted.

#### Motion 2359 was proposed by Cllr. Siobhán Ambrose

That under Clonmel Borough District Councils future roads programmes that consideration is given for the re-surfacing of the last section of the Cherrymount estate (Ref my previous motions).

#### Reply:

The District Engineer will include this road for consideration as part of the Road Works Programme for 2022.

The motion was seconded by Cllr. Michael Murphy. The reply to the motion was noted.

#### Motion 2360 was proposed by Cllr. Siobhán Ambrose

That under Clonmel Borough District Councils future road programmes, that consideration is given for providing additional car parking spaces around the green area opposite No. 4 in Fairfields (Ref my previous motion on this issue).

## Reply:

The District Engineer will include this road for consideration as part of the Road Works Programme for 2022

The motion was seconded by Cllr. Michael Murphy. The reply to the motion was noted.

# Motion 2361 was proposed by Cllr. Siobhán Ambrose

That under future roads programmes that consideration is given for resurfacing the final section of the Glenview Close Estate.

# Reply:

The District Engineer will include this road for consideration as part of the Road Works Programme for 2022.

The motion was seconded by Cllr. Michael Murphy. The reply to the motion was noted.

### CAPITAL ASSISTANCE SCHEME VOLUNTARY HOUSING

Focus Housing Association completed the purchase of a 2-bed unit at 37 Albert Street, Clonmel in February 2022 which will house disabled users.

Cluid Housing Association  $-9 \times \text{units}$  at Glenconnor Road, Clonmel, Co. Tipperary. Stage 4 approval received. Contractor on site with a planned completion at end Q2 2022.

## **Housing Grant Allocations**

The Council has received confirmation that we can proceed with allocating 65% of last year's funds for works to be carried out in 2022. This is in expectation that this year's allocation, yet to be confirmed, will at least match that received in 2021. This was €3,417,076 for private housing adaptation grants and €1,533,332 for local authority grants.

The scheme has now opened up to P1, P2 & P3 applications for 2022 for both private and local authority grants.

### **Community Activities Fund**

DDS Architects will conduct a walkability audit in Clonmel on the 28<sup>th</sup> and 29<sup>th</sup> of March. The Dementia Mobile Unit will be in Clonmel on Friday 8<sup>th</sup> April. Following the mobile unit and pop up shop we aim to engage business and community groups to participate in training with the Alzheimer Society.

#### **Tipperary Age Friendly**

Tipperary Age Friendly will promote an Older Adult small grants scheme to compliment Bealtaine which will be advertised though Tipperary PPN in March. We are also partnering with Tipperary Arts and Tipperary Libraries to showcase Bealtaine. We will work with the BCP locations in the Clonmel Borough District for streaming of events during Bealtaine, and encourage neighbouring locations to attend and enjoy social events in these locations. We are also partnering with the Memory Technology Library, Tipperary Library Service and the Dementia Advisors in promoting e health and the use of the Magic Tables as a tool in the BCP locations.

#### Jigsaw

Jigsaw are actively seeking an outreach centre in Clonmel with locations such as the Community Resource Centre at Kickham Street as possible options;

# Comhairle na nÓg

The first full meeting of the new Tipperary Comhairle took place in December 2021 to train all members in Committee skills and also to vote on elements of "Youth health" which is this year's theme, which they will be working on during 2022. In January/February, the subgroup meetings took place so that each group could vote on officers and plan upcoming actions in each area (these meetings took place by Zoom).

## FAI Spar Primary 5's School Competition

Following feedback from Schools in relation to the impact of the COVID-19 pandemic, The FAI have taken the decision partners SPAR to approach the SPAR FAI Primary School 5s Programme differently this year. Under this new format, Schools are asked to run their own 5-a-side competitions for pupils, and the FAI will provide guidance on how to do this. Registration is currently open for schools, currently there are 45 schools in Tipperary signed up. Ongoing communication and support with schools who have registered will be provided.



This scheme provided funding for individual tourism and hospitality businesses to develop and increase their own outdoor seating capacity. Grants of up to €4000 were made available with an extended closing date of 8th October 2021. The scheme is

now closed and all drawdowns complete, 39 payments have been processed by the Clonmel BD with an associated value of €112,730.33.

# **Equine Tourism / Thoroughbred Country**

Tipperary County Council and Tipperary Tourism are working in partnership with Fáilte Ireland, Kildare County Council and Kildare Fáilte to develop equine tourism experiences across the county connected nationally through a Thoroughbred Experience Trail and to jointly deliver the Fáilte Ireland Thoroughbred Country Visitor Experience Development Plan. Thoroughbred Country was launched in November at the Irish National Stud. The current pilot programme includes Hotel Minella, Minella Stables and Tipperary Museum of Hidden History.

#### Munster Vales

Munster Vales rolled out a **Community Engagement Programme** which was aimed at upskilling communities to welcome and retain tourists, enhancing the relationship between active community groups and Munster Vales. Tourism businesses from the Comeraghs and Clonmel area took part in this programme. A networking event for all involved and interested businesses and communities will take place on March 30<sup>th</sup>.

Munster Vales received a wonderful review from David Cullen of **The Irish Times** on his short break around Munster Vales. David highlighted the *Taste The Vales* campaign which is a food experience trail featuring sumptuous café and dining experiences within the region including The Tipperary Food Producers, Fodar, Hotel Minella and Raheen House. Munster Vales will feature in the **Glance Promotions Visitor Guide** which is currently in development. This visitor guide is distributed nationally. The advertisement will reference Munster Vales Slow Adventure Itineraries which highlight Clonmel showcasing attractions like Suir Blueway Tipperary, St. Patricks Well and the Tipperary Museum of Hidden History.

Munster Vales is nearing the completion stage in the development of an **interactive trails map** which will showcase walking routes and heritage sites within the region. The interactive map will feature Suir Blueway Tipperary along with walks that fall within the Comeragh mountain range. Munster Vales will showcase over 80 walks within the region and will be a welcomed addition in promoting the outdoor experiences within the area.

Munster Vales has developed a **training analysis survey** which aims to capture any gaps that exist in the skills sets of tourism providers and community tourism groups. The Evaluation & Approvals Committee have evaluated and approved a total of €136,350 funding support in the form of Business Expansion Grant of €100,000 (subject to ratification from EI Finance Committee) and Priming Grant of €36,350. This grant funding will leverage an investment of €442,502 into the Clonmel area and help create 13.5 full time positions

#### **Green for Micro**

#### 5 applications approved to date.

The aim of the Green for Micro programme is to assist businesses in lowering their carbon footprint, reducing costs and improving the environmental profile of the business in the marketplace.

The programme is designed to allow eligible companies to avail of technical and/or advisory supports from external experts across a broad range of activities from resource efficiency to understanding their carbon footprint to implementing an environmental management system.

The programme benefits for clients include:




identified properties. A training program was under taken to inform all relevant staff of the detail of the scheme and promotional documentation is prepared for finance staff to issue to the new rates clients.



The plenary Council passed a resolution at their September 2021 meeting agreeing to increase the base Local Property Tax (LPT) in Tipperary by 10% for 2022. Half of this increase has been apportioned as an additional allocation to the District General Municipal Allocations (GMA) in the 2022 Adopted Budget. The total county allocation for the GMA for 2020 is €953,680. This is allocated to the five districts based on population at the time of the 2016 Census.

"Festivals and events are crucial to the fabric of life in County Tipperary and they deliver a range of economic, social and cultural benefits". Despite the difficulties posed to the sector by the Covid-19 public health pandemic, Tipperary County Council still aims to promote and support local events throughout the County that are not solely commercially focused, to support and assist those events that have a tourism/cultural/artistic/sporting or community focus and which contribute significantly to quality of life. The Tipperary Festivals and Events Scheme is a mechanism to ensure a consistent approach to support for Festival Development in Tipperary in line with the Tipperary Festivals & Events Strategy.

A call for applications for support for Festivals & Events taking place in 2022 was issued in late 2021 with a closing date of 28<sup>th</sup> January 2022. Applications were invited under various categories as defined in the Tipperary Festivals & Events Strategy; Community, Municipal and Premier categories, each with associated criteria and funding bands as outlined in the application guidelines for the scheme. All events that take place must comply with Government public health guidelines in force at the time.

In the Clonmel Borough District two categories were assessed by the County Assessment Group: one application was received under the Premier Category - the Clonmel Junction Arts Festival which is covered under a 3-year funding programme.

Five eligible applications were received from the District under the Municipal Category - funding support has been recommended to applicants that met the criteria and is as detailed in the attached list.

Dear Cllrs,

I refer to a recent motion approved by the Clonmel Borough District members requesting information from NAMA.

As you may be aware, NAMA acquired loans with a par debt of €74 billion from the five participating Irish banks during 2010-2011. There were over 60,000 properties securing these loans. It is important to note that the properties were not acquired by NAMA and remained in the ownership and control of their registered owners, or appointed receiver if enforced. NAMA did not compile a breakdown of the value of the secured properties in Ireland by municipal or borough district. However, we can advise that, on acquisition, the total value of properties securing NAMA's loans in the Tipperary County area was c.€150m (based on 2009 valuation date).

NAMA is now at an advanced stage in the process of deleveraging its loan portfolio, which largely comprised the sale of properties by their owners / receivers, and I can confirm that there are no remaining secured assets in the Clonmel Borough District area or in the wider Tipperary County Council area.

I trust that this information will be of assistance to the Clonmel Borough District.

I would like to thank you for your letter dated 24th January on behalf the members of Clonmel Borough District seeking clarification in relation to public health restrictions and guidelines put in place over the course of the COVID-19 pandemic. The Minister hopes the members find the below information helpful.

Since Ireland's declaration of the COVID-19 pandemic in March 2020, its national response to COVID-19 has been supported by a public health-led, whole-of-government approach. This whole-of-government approach involves cohesive decision-making, a partnership approach, expert public health advice, and clarity of communications.

The NPHET for COVID-19 has provided evidence-based advice to the Minister for Health on the public health aspects of the cross-government strategic response to COVID-19 nationally. At all times, the NPHET's advice has been informed by the epidemiological status of the disease, modelling projections, international advice, and guidance, evolving evidence and practice both nationally and internationally, and the overarching priority of limiting the impact on public health, and in particular protecting the following three core priorities:

- The protection of the most vulnerable;
- the continued resumption of non-COVID health and social care services;
   and
- the need to protect the ongoing delivery of education and childcare.

Actions, decisions, and recommendations arising from NPHET meetings have at all times been made by consensus and on a collective basis.

Commitment to the principle of transparency has remained central to the work of Government and the NPHET on the COVID-19 response. Accordingly, strong emphasis has been placed on the online publication of advice and decision-making material to the greatest extent possible.

The Government's strategy has been guided by an evolving understanding of the disease and its emerging variants, the impacts of restrictions on health and well-

being as well as other aspects of society and the economy. Five separate plans since March 2020 have demonstrated an evolving response to the crisis:

While all remaining mandatory public health measures were removed from 28th February as advised by the NPHET, the critical components of our collective and layered response will remain. These include: Sector specific measures, based on risk assessments by individual sectors, to ensure a safe environment, continued advice to wear facemasks in certain circumstances (in particular on public transport and in healthcare settings), rapid self-isolation if symptomatic or if diagnosed with COVID-19, vaccination, continued hand and respiratory hygiene, practicing of physical distancing and avoidance of crowded environments based on individual risk assessment and with a continuing focus on protecting others.

It is acknowledged that, over the coming period, people will perceive the risk of COVID19 infection in different ways, depending on their individual medical history and experience of the pandemic to date. For many, the further easing of measures as recommended at this time will lead to some uncertainty with regard to the adoption of protective behaviours. It will be important that people's individual choices with regard to physical distancing, use of facemasks and other protective measures are respected over the coming period. A programme of public health communications is being progressed in this regard.

The Office of the Chief Medical Officer will continue to closely monitor the epidemiological profile of the disease and will remain available to provide any further advice and recommendations that may be of assistance to the Minister for Health and Government in relation to ongoing decision-making processes in respect of the COVID-19 pandemic.
