then **sign and return the form via post** to Tipperary County Council, Revenue Section, Civic Offices, Nenagh, Co. Tipperary. **We can only accept original signed forms.** Please note that we are

unable to accept scanned copies of the form sent via email.

PAYING: The payments will be automatically deducted from your bank account

on the **10th day of each month (as per your preferred option overleaf)**, or the next working day where the 10th falls on a weekend

or bank/public holiday.

ARREARS: Any outstanding arrears will be payable with the 1st moiety via direct

debit.
