ACTIVE TRAVEL

On 1st February 2023 the council received notification from the National Transport Authority of an allocation of €4,633,000 for Active Travel Schemes in 2023 (see full details hereunder). In 2021 and 2022 Tipperary Council, with the support of the NTA, secured additional funding for projects throughout the year and an expansive programme of much needed active travel infrastructure was delivered across the County.

The active travel funding programme, now in its third year, has established a portfolio and pipeline of high-quality active travel schemes in Tipperary and across the country with several schemes at an advanced delivery stage and many at construction. Construction inflation during this period has also added to pressures on the available funding for the delivery of the programme. As a result, it is less likely that Tipperary County Council will secure additional funding for projects during this year.

Initially, while establishing the Active Travel programme, a considerable proportion of our projects were delivered under bundled schemes such as footpath packages, which meant their delivery and approval process was relatively simple as per the NTA Simplified Project Approval Process for minor works; this ensured that projects got to construction quickly.

As the scale and complexity of our projects has increased, and with the unwinding of the bundle scheme delivery approach, it necessitates the need to secure additional formal "Gateway" and "Hold Point" approvals to progress to the next project phase, such as planning and construction.

In February 2023 the NTA published a Guide to Rapid Build Active Travel Facilities. All schemes now require a Rapid Build Options report which focusses on traffic calming, reducing the vehicle carriageway and road space rebalancing. Projects may now be deprioritised if a rapid build option is not possible. At each stage the project is reviewed for alignment with national policy and the NTA's priorities, with the focus being to maximise the kilometres of active travel infrastructure delivered with the available resources. Key priorities are:

- utilising road space reallocation as a first option to deliver active travel infrastructure
- implementation of shuttle systems in line with the National Investment Framework for Transport in Ireland (NIFTI) which prioritise future investment by the intervention hierarchy of Maintain, Optimise, Improve and New Infrastructure (in that order)
- prioritising projects that have the greatest potential for modal shift to sustainable modes to achieve the Climate Action Plan targets of 1,000km of new active travel infrastructure to be built by 2025
- prioritising the fast tracking of projects currently on the programme at an advanced stage in the project cycle, such as construction or near construction
- ensuring current schemes are reviewed and layouts updated to future proof them for alignment with new design guidelines to be issued in the coming months as part of the updates to the National Cycle Manual.

Given the shift away from bundled, small scale projects, towards the delivery of a network of cycleways, whilst maximising the amount of active travel Infrastructure delivered for the available funding, has resulted in a lengthening of the time taken to secure the necessary formal approvals to progress schemes through the project design stages, as well as approvals to proceed to construction.

ROAD SAFETY

Road Safety Section sponsored coverage of the Munster Senior Challenge Cup Final between Nenagh Ormond and Young Munster on Tipp FM. It was the first time that any Tipperary rugby team had reached the final. The messaging targeted a predominantly male audience and urged people not to text while driving, not to drink and drive and to slow down.

The Road Safety Section also published a new brochure "Road Safety for Older Adults", which offers road safety tips for pedestrians, on medicines and driving, using roundabouts and meeting cyclists on the road.

PUBLIC LIGHTING

A new Public Lighting policy was adopted by the Council in December 2022. Public lighting queries are dealt with daily by the Roads Section, the Customer Service Desk and the Municipal/Borough Districts. Enerveo (formerly SSE Airtricity) is notified of the relevant queries and corrective action is taken as appropriate.

Tipperary County Council has responsibility for the management and maintenance of more than 17,800 lights in the county and public lighting is the biggest user of energy in the Council's overall energy usage.



Tipperary County Council is participating in the National Public Lighting Energy Efficiency Project (PLEEP) which will see 11,600 lights upgraded to LED across Tipperary. This project is being rolled out on a regional basis with Tipperary County Council included in the Eastern region. Kilkenny County Council is leading the project in the region. Tipperary County Council continues to engage with the lead partner in preparing for the project commencing in Tipperary later this year.

EV CHARGING

EasyGo, in partnership with *eir*, and working with Tipperary County Council are progressing with the proposed installation of Electric Vehicle Chargers across Tipperary which will see the company investing €600,000 into the county. This involves the installation of thirteen new fast electric vehicle (EV) charging stations in County Tipperary, providing 18 charging points.

eir and EasyGo have joined forces to develop new charging points across the country, to accommodate the growing number of EVs on our roads. Electric

vehicles accounted for 24% of all new cars sold between January and March 2023 - surpassing diesel car sales for the first time. Installing these chargers in easily accessible town centre locations, will increase the appeal of EVs for drivers, greatly extending the accessibility of charging points and thus the range of the vehicles. Transport accounts for one-third of Ireland's energy-related CO2 emissions so increased adoption of EVs is a key aspect of Ireland's Climate Action Plan.

The EasyGo network is today used by more than 42,000 Irish EV drivers who can avail of charging at more than 3,000 charge-points nationally.

The EV chargers to be installed in Tipperary will be found in: Ballina, Borrisokane, Cahir, Carrick-on-Suir, Cashel, Clonmel, Fethard, Nenagh, Newport, Roscrea, Templemore, Thurles & Tipperary Town. Installation of these chargers will commence in June taking a few months to have these rapid chargers installed and operational.

These installations mark the continuation of the rollout of this programme nationally. Throughout this programme, **EasyGo** and *eir* will utilise Tritium's world-first, next-generation simultaneous DC Rapid Chargers, adding up to 100km range to an Electric Vehicle in just 15 minutes.

Brief Description

Grangemockler is located on the N76 in the Carrick on Suir Municipal District. Traffic volumes passing through the village are approximately 5,500 AADT including 6% Heavy Goods Vehicles. The scheme was selected for use as a Pilot Scheme for the development of Transport Infrastructure Ireland (TII) standards for the design of similar works in urban areas.

The Studies

Visual surveys indicated that the existing pavement was suffering structural failure. Serious rutting and surface deformation were plainly evident. Surveys indicated that a pavement repair of up to 200mm was required on sections of the road. The local Church and the Community Hall were not connected by footpaths to the local housing estates. Parking was not defined which led to hazardous conditions for pedestrians crossing the road. Existing footpaths were narrow in various locations.

Objectives of the Scheme

It was recognised from the start that a key objective was to maintain access to properties and to maintain the flow of traffic on the N76. There are no suitable diversion routes to allow the road to be closed to facilitate the construction. In addition to the main purpose of rehabilitating the road pavement, further objectives include the improvement of the village environment, definition of the carriageway widths and provision of parking.

The Process

Approvals of the Design were obtained through the Part 8 Planning process and also from Transport Infrastructure Ireland (TII). The design includes high quality materials and extensive hard and soft landscaping to improve the village environment which will assist in reducing vehicle speeds in the village. The Works proceeded through to completion in May 2023.

PLANNING SECTION

Local Area Plans for Clonmel, Nenagh, Thurles and Roscrea

With the Tipperary County Development Plan 2022-2028 now in place, progress on the preparation of Local Area Plans for the Key Towns and District Towns in the County has commenced. The Tipperary County Development Plan 2022-2028 sets out a Core Strategy for the development of towns and villages in the County. The plan sets out the character, potential and vision for growth as demonstrated in the Town Profile Plan for Key and District Towns which will inform the preparation of a new Local Area Plan. The Town Profile Plans set out a baseline for the towns with key socio-economic data such as jobs ratio, transport modes, housing stock etc. In particular, the compact

growth area and walking and cycling proximity as indicated, will support low-carbon development patterns including local transport planning and town centre

The Planning Section has commenced the background research and survey work and an external environment team have been commissioned to prepare the Strategic Environmental Assessment, Appropriate Assessment and Flood Risk Assessment. Workshops have taken place with Elected members in October 2022, an Issues Paper published for each LAP and Public Consultation Events took place in November 2022.

A draft Roscrea Local Area Plan was published on 24th February 2023 and submissions were invited until 11th April 2023. 19 submissions were received (1 late submission was also received). These submissions have been summarised and recommendations provided within the Chief Executive's Report on the Draft Roscrea Local Area Plan 2023-2029. Workshops were held with Elected Members in late May to discuss the CE report and the Draft LAP. A decision to adopt or amend the Draft LAP will be made at the June Plenary meeting. If a decision is made to amend the Draft LAP, the amendments will be published for public consultation from 25 June 2023 to 24 July 2023.

Working Draft LAPs have been prepared for Clonmel Nenagh and Thurles and workshops on each of the LAPs took place with the members in late May and early June to discuss the Draft LAPs before they are made available for public comment. Draft Local Area Plans for Clonmel, Nenagh and Thurles will be published in late July 2023. Further public consultation will take place in accordance with legislative provisions.

Residential Zoned Land Tax

As set out in Housing Policy Objective 15.2 of Housing for All, a new tax to activate land for residential purposes, and which will in time replace the Vacant Site Levy, has been introduced by the Department of Finance and the Revenue Commissioners in conjunction with the Department of Housing, Local Government and Heritage as a Land Activation Measure.

The Residential Zoned Land Tax provisions of the Finance Act 2021 set out criteria to facilitate the identification of lands which fall within the scope of the tax. The Planning Authority are responsible for preparing and publishing maps based on this criteria. These maps are to be based on the local authority development plan and where relevant, local area plan zoning maps i.e. where land is zoned and suitable for residential development. The legislation also sets out certain lands which are to be excluded from the scope of the tax.

All land that was zoned for residential development, or residential development and a mix of other uses, in a development plan or local area plan, before 1 January 2022 and which remains subject to the relevant zoning on that date, is liable for consideration within the initial scope of the Residential Zoned Land Tax. This is intended to encourage activation of existing planning permissions on lands which are identified as



being in scope and to incentivise suitable lands without planning permission to commence the process of engagement with planning authorities.

Draft maps were published on November 1st 2022 and were subject to a consultation period until January 1st 2023. A total of 91 submissions were received. These submissions have been reviewed, and where necessary, a referral to statutory consultees and internal sections of Tipperary County Council, was issued, requesting information to assist with determinations of submissions. A formal determination / decision, where necessary, was required to be notified to the landowner by 1st April 2023. 62no. notifications of determinations were issued by Tipperary County Council.

Landowners, to whom determinations were notified, had a right to appeal the determination to An Bord Pleanála by 1st May 2023. Tipperary County Council has been notified by An Bord Pleanála of 18 no. appeals received. The planning section is currently preparing to send background documentation, which informed the determinations, to An Bord Pleanála. An Bord Pleanála must make a decision not later than 16 weeks from date of receipt of the appeal.

In addition, a further review and assessment has been undertaken to identify any additional sites that come into scope for the tax, with these sites included on a Supplemental Map, which was published on 1st May 2023, and on which submissions can be made not later than 1st June 2023. A formal determination / decision by Tipperary County Council will be required on submissions received by landowners which request a site to be excluded or which challenges the in-scope date of a site, and a notification of such determinations must be notified to the landowner by 1st August 2023. The landowner has a right to appeal the local authority's determination to An Bord Pleanála by 1st Sep 2023. A Final Map will be published on 1st December 2023.

A workshop was held with the Elected Members on 30th January 2023 and a subsequent workshop was held on 24th May 2023.

Town Centre First (TCF) / Town Regeneration Officer (TRO)

Tipperary Council was awarded funding earlier this year of €100,000 to deliver a Town Centre First Plan for Roscrea Town. The funding has been awarded under the Department of Rural and Community Affair's "Our Rural Future", Ireland's Rural Development Policy 2021-2025. The plan will help to develop Roscrea's own unique vision and plan for its future development and once complete, will provide a basis for the town to seek support from multiple funding streams, including the Rural Regeneration Development Fund, (RRDF) and the Town & Village Renewal Schemes. A Town Regeneration Officer was appointed in November by Tipperary Council and will initially work with Roscrea as the first pilot town in the County to have a TCF plan developed. The first steps will be to establish a Town Team for Roscrea for which expressions of interest were received as part of a public consultation process during the summer. A contract will be awarded shortly to appoint consultants to support the delivery of the Town Centre First Plan with the TRO and a timeframe for completion has been set for the summer of 2023.

Urban and Rural Regeneration and Development Fund: Project Implementation

The National Development Plan (NDP) 2018-2027 established four new funds to help drive the specific core priorities detailed in the NPF (National Planning Framework). These four funds included an Urban Regeneration and Development Fund administered by the Department of Housing, Planning and Local Government and the Rural Regeneration and Development Fund administered by the Department of Rural and Community Development. The following projects are currently being delivered.

Clonmel 2030 Transformational Regeneration seeks to develop a multi-dimensional, public/private/community partnership proposal for Clonmel, which will re-imagine how civic, cultural, educational, enterprise and tourism uses can work together to regenerate and create a new role for the town. The project includes four intrinsically linked and integrated pillars, namely: Kickham Barracks Regeneration, Clonmel Regional Sports Hub, Clonmel – Flights of Discovery and Clonmel Public Realm Enhancement. Funding was received for proposed Category A works in 2019 relating to Kickham Barracks Regeneration Phase 1 and Clonmel Regional Sports Hub. Both elements of the project are substantially completed and snagging is in progress. Total project costs approved are €15,163,247 and URDF grant awarded is €10,594,961.

Liberty Square Enhancement Scheme, Thurles seeks to deliver a vibrant Liberty Square at the heart of Thurles: a place to live, shop, work, socialise, play or "hang-out". The revitalised Liberty Square will become an engine for growth in and around Liberty Square and will enhance the attractiveness of Thurles as a place to live and a place for investment / employment. Funding was received in 2019 to undertake works to the Eastern end of Liberty Square and to develop a new car park off Liberty Square. Additional funding of €1m was secured in March, 2021 to undertake enhancement works to the Western end of Liberty Square and the junctions of the approach roads. Phase 1 works are fully completed. The Project Management Plan for the delivery and implementation of Phase 2 of this project is ongoing. Total project costs approved are €10,700,291 and URDF grant awarded amounts to €5,390,291.

A Pathway to a Low-Carbon Society: A Centre of Excellence for Sustainable Energy driving the transformational urban regeneration of Nenagh: -The proposal is to develop a Centre of Excellence for Sustainable Energy, to be the anchor and catalyst for the redevelopment of Martyr's Road Regeneration Quarter, a 10 ha. strategic site of brownfield lands and underutilised properties located in the heart of Nenagh Town Centre. The Centre of Excellence, taking reference from best international practice, will uniquely host a range of public agencies working collaboratively to deliver innovative solutions from training and development, to new cutting-edge research on technologies, to incubating low-carbon social enterprises. The Centre has been designed to be Ireland's first carbon neutral and energy positive building. The works to be supported also include Public Realm and Amenity Enhancement to Friar Street Civic Plaza, Martyr's Road Town Park, Martyr's Road streetscape improvements, including cycleways. Funding was approved in March, 2021 under the Second Call for funding support from the Urban Regeneration Development Fund. The Project Management Plan for the delivery and implementation of this project is ongoing. **Total project costs approved are €12,700,000 and URDF grant awarded amounts to €9,525,000.**



Sustainable Energy Centre of Excellence, Nenagh

Tipperary Town Regeneration - This is a significant regeneration project for Tipperary Town which will greatly enhance long term sustainable tourism for the area. It includes: Upgrade of the Market Yard as a pedestrian priority area linking the Excel Heritage Centre to Market Yard and the Town Centre; Development of an 800m gravelled walkway parallel with the existing river channel and connecting to the existing path near Glenview; Installation of a new pedestrian bridge to access the walkway from the Link Road. Funding was approved in 2018 under the Rural Regeneration Development Fund. This project is completed. **Total project costs approved are €1,442,018 and RRDF grant amounts to €1,081,513.00.**

The project proposal is for the development of a community sport and recreational campus, incorporating a community pavilion, playing pitches, walkways, parkland and open spaces. The project was developed through a partnership approach with Coolmore Ireland, Cashel and Emly Diocese and Healthy Ireland. Funding was approved in 2019 under the Rural Regeneration Development Fund. This project was completed in early April, 2023 and opened to the public on 8th. April. **Total project costs for Phase 2 Pavilion and Public Realm Works are €3,137,927 and RRDF grant amounts to €3,003,445.**

Groundworks and pitches together with the stand and community annex of the pavilion were funded by the Magnier Foundation (Coolmore Ireland).

The project proposal is a flagship urban regeneration project to conserve and establish Templemore Town Hall as an economic, cultural and community hub of the town, the District and the Mid-West Region. The project was prepared by the Council in partnership with Garda Training College, Templemore College of Further Education, Templemore Community Development Association, the

The Project Management Plan for the delivery and implementation of this project is ongoing. Total project costs approved are €4,014,746 and RRDF grant amounts to €3,011,060.

Nenagh Historic & Cultural Quarter - A Tourism-led Regeneration Plan

It comprises a Plan to regenerate specific existing buildings and civic spaces of distinction and value within Nenagh (including The Gaol, The Castle and Banba Square) to stimulate tourism growth and revitalise the local economy/visitor economy within a context of tourism-led regeneration, comprising arts, history, heritage and culture. The focus will be on the development of 3 Flagship Pillars and 3

Supporting Pillars, collectively offering an immersive tourism experience. Funding was approved in 2020 under the Rural Regeneration Development Fund. The Project Management Plan for the delivery and implementation of this project is ongoing. Total project costs approved are €896,712 and RRDF grant amounts to €672,534.

Carrick on Suir Regeneration Plan 'A Journey from the Suir Blueway to the Ormond Castle Quarter'

Plan for the town, through investment in orientation and public realm enhancement actions, to build on its relationship and synergies with the Suir Blueway (west) and the historic Ormond Castle Quarter (east) and thereby regenerate the town centre as an immersive visitor destination and rural town in its own right. Funding was approved in 2020 under the Rural Regeneration Development Fund. This Category 2 project is completed. **Total project costs approved are €487,500 and RRDF grant amounts to €365,625**.

A Pathway to the Regeneration of Cahir Town Centre: Re-establishing the Historic Square as the Living-Working Quarter

A suite of measures that will re-vitalise Cahir's historic Square as a living-working quarter. The project will provide a dynamic town centre Square with a focus on pedestrian priority and civic space. The redevelopment will be focused around Market House, a flagship Business Development Centre based in one of the most historic buildings on the Square. Funding was approved in 2020 under the Rural Regeneration Development Fund. This category 2 project is completed. **Total project costs approved are €986,354** and **RRDF grant amounts to €663,362.**

Thurles Market Quarter: Regeneration through Recreation, Education and support for Local Producers is a collaboration between Tipperary County Council, Thurles Lion's Club and Mary Immaculate College Thurles. The project will provide a designated market space in the town centre for local food and craft producers, artists and performers; will offer a location in the centre of a cluster of civic spaces to be enjoyed by locals and visitors while also acting as a base for the MIC Students' Union. The project was awarded RRDF Funding in April, 2021. The Project Management Plan for the delivery and implementation of this project is ongoing. **Total project costs are €3,825,700 and RRDF grant amounts to €3,443,130**.



Kilsheelan – Revitalisation of Rural Villages: A Model for Cluster Housing and Low Carbon Planning The project has been developed as a demonstrator scheme to show the practical implementation



of Tipperary County Council's 'Design and Best Practice Guidelines for Cluster Housing'. The guidelines include a series of case studies illustrating how sustainable design solutions can be developed across a range of village types and site options. This project will be model for serviced site developments across the Country and an initiative to revitalise villages in Tipperary and nationally. The scheme at Kilsheelan was subject to a Part 8 process and approved by the Elected Members in July, 2019. The project also includes the development of a new public park in the heart of this picturesque village and a new arrival point for the River Suir Blueway. The project was awarded RRDF Funding in April, 2021. The Project Management Plan for the delivery and implementation of this project is ongoing. Total

project costs are €670,833 and RRDF grant amount is €603,750.



Rialto Digital & Enterprise Hub, Nenagh

Funding has been approved to prepare detailed designs and planning for the adaptive re-use of the former iconic 1940's Rialto cinema into a modern digital and enterprise hub facility using best practice and appropriate modern architectural intervention to provide excellent office, collaboration and meeting spaces. The associated brownfield site will be master-planned to explore the potential for further digital and enterprise office space, the creation of a new streetscape along Emmet Place, the potential provision of town centre residential units and the delivery of a new public amenity heart in the town centre. The Hub will be an exemplar sustainable, green, town centre regeneration project that will revitalize the town centre of Nenagh through the provision of much needed incubator enterprise space, public realm enhancement, improved permeability/linkages with existing streets and backland/infill development through planning for the delivery of town centre homes. The overarching aim and purpose of the proposal is to promote economic development and increase employment opportunities while preserving and saving a protected historic structure which was purchased by the Council in December,2020. The project was awarded RRDF Funding in January, 2022. The Project Management Plan for the delivery and implementation of this project is ongoing. **Total project costs are €1,511,059 and RRDF grant amounts to €1,208,847.**



Proposed Rialto Digital & Enterprise Hub

Carrick-on-Suir Regeneration Plan - 'A Journey from the Suir Blueway to the Ormond Castle Quarter - Delivering Our Community's Ambition'

This project follows on from the successful Category 2 RRDF application for the planning and design of extensive public realm enhancements in the town centre, development of Suir Blueway linkages and the regeneration of the Ormond Castle Quarter. Improvements will consist of (i) the transformation of Main Street, Sean Kelly Square, Greystone Street, Ball Alley Street and Chapel Street through the installation of high-quality public realm; (ii) provision of a new Enterprise and Digital Hub in a vacant town centre building owned by An Post on Main Street which will be managed

and operated by Carrick on Suir Tourism and Economic Development Committee; (iii) the creation of an arrival point at Sean Healy Park through design, enhancment and orientation measures integrating





best practice in user needs for kayakers, cyclists, walkers and other users and the integration of the Suir Blueway Tipperary into the town centre through the creation of shared spaces along the Quays and

linkages to Main Street.; (iv) public realm upgrade of Castle Street and repurposing of Ormond Castle Park as a high-quality Amenity and Biodiversity Park. Funding was announced by Minister Heather Humphreys under Phase 1 on 10th. November, 2022. **Total project costs amount to** €17,989,387. **RRDF grant approved** is €14,391,509.



Activating Cahir's Town Centre Regeneration Strategy This project follows on from the successful Category 2 RRDF application for the planning and design of a new Business Development Centre in the heart of Cahir, public realm enhancements in the centre of the town and the development of a car park on a central backland site. Improvements will consist of (i) the restoration and redevelopment of the vacant Cahir Market House and former Council Offices into a Business Development Centre which will be run

by Cahir Development Association and provide offices, a large training and conference room, co-working spaces and hot desks to satisfy the unmet demand in the town (ii) the refurbishment of the historic Granary building to provide a state-of -the-art library for the community; (iii) Cahir Square Public Realm Enhancements to include the recalibration of the traffic circulating around the Square to a more rationalised flow that prioritises pedestrian and cyclist movements and



the redistribution of public realm in favour of recreational space; (iv) the provision of a new car park consisting of 86 car parking spaces, coach parking, EV charging, and bicycle parking on disused backlands off Church Street which will involve the demolition of two derelict vacant buildings that were acquired by the Council under the Category 2 approved project. Funding was announced by Minister Heather Humphreys under Phase 2 on 10th. November, 2022. **Total project costs amount to €14,894,686. RRDF grant approved is €11,915,749.**

Reimaging and Regenerating Gantly Street - Towards an Age Friendly Neighbourhood for Roscrea

This project will deliver a transformational change to the public space around Gantly Road and promote regeneration of town centre brownfield land through the activation of the surrounding lands. The project will be the catalyst and first phase in the implementation of the Gantly Street Age Friendly



Neighbourhood, an ambitious masterplan to create a more vibrant and appealing place for people of all ages to address specific social, environmental and economic challenges within the community. The works will involve (i) the realignment of Gantly Street to provide for improved pedestrian and cycle infrastructure in accordance with Age Friendly principles; (ii) the creation of high-quality public realm areas and footpaths; (iii) extensive bio-retention rain gardens and (iv) the provision of water service and utilities infrastructure to service the Gantly Road Age Friendly Masterplan area. The

regeneration and re-imaging of Gantly Street is critical to the overall delivery of the Gantly Street Age Friendly Neighbourhood masterplan area into the future. Development of the Gantly Street masterplan area will transform a central area of Roscrea, create opportunities to provide homes, business and amenity space for local residents to enjoy and lead to knock-on socio-economic benefits for the whole of the town. Funding was announced by Minister Heather Humphreys under Phase 2 on 10th. November, 2022. **Total project costs amount to €5,639,145. RRDF grant approved is €4,511,316.**

Conservation Grant Schemes 2023

The **Built Heritage Investment Scheme 2023** seeks to encourage the conservation of structures protected under the Planning and Development Act 2000 (as amended) and in certain cases, structures within Architectural Conservation Areas. The scheme also seeks to support the employment of skilled and experienced conservation professionals, craft workers and trades people.

The allocation for Tipperary County Council under the scheme for 2023 is €126,000. Tipperary County Council also received an extra allocation of €21,377 under the supplementary ring-fenced funding for historic thatched structures.

30 applications were received under the scheme for 2023. The closing date was the 23rd January, 2023. 24 projects were recommended by RIAI Grade 1 Conservation Architect, Michael O'Boyle after a thorough assessment was carried out. The Department of Housing, Local Government & Heritage approved grants ranging from €2,500 up to €11,000 as follows:-



E-Planning

In association with the Department of Housing, Local Government and Heritage (DHLGH), and the Local Government Management Agency (LGMA), Tipperary Planning Authority has successfully completed the pilot of phase one, two and three of planning portal https://planning.localgov.ie. During our first full year live on the planning portal over 50% of applications were received online. Set out below are the monthly figures % of E- applications received by month for 2022 and 2023 in Tipperary. In first 3rd of 2023 51% of submissions received, were received via the portal. Work is continuing with the LGMA and our third-party providers and part 8 applications are now online with six from Tipperary currently on the planning portal. We continue to liaise with the other 17 iPlan sites who have gone live on the planning authorities to go live: Galway County, Westmeath, Kilkenny, Limerick, Waterford, Carlow, Cavan, Clare, Leitrim, Louth, Meath, Mayo, Monaghan, Sligo, Wicklow and Laois. It is planned that the remaining iPlan authorities will go live in the first half of 2023 and the Apas/Odyssey planning authorities also.







Irish Planning Institute Annual Conference 2023.

Tipperary Council hosted the Irish Planning Institute Annual Conference, 2023 which was held at Hotel Minella, Clonmel on 20th and 21st April 2023. The conference was attended by nearly 300 delegates. Kieran O'Donnell TD, Minister of State at the Department of Housing, Local Government and Heritage attended and gave a keynote address.

Contributions at the conference from Cathaoirleach Roger Kennedy, Director of Services Sinead Carr, and Acting Senior Planner Anne-Marie Devaney demonstrated the significant ambition and innovation of the Council in developing and delivering tourism, regeneration, technological and climate action projects throughout the county.





Energy and Farm Diversification Show (formerly the Energy in Agriculture Show)

The launch of the Energy and Farm Diversification Show (formerly the Energy in Agriculture Show) took place recently. In attendance was the Minister for Agriculture, Food and the Marine, Charlie McConalogue TD, as well as representatives from the show's organising committee and main sponsors.

The Energy & Farm Diversification Show is a collaboration between Teagasc, Tipperary County Council, Irish Farmers Association, Tipperary Energy Agency, Macra Na Feirme, Gurteen College and TUS Midlands Midwest.

This one day show incorporates a large trade exhibitor showcase, outdoor practical demonstrations, networking opportunities with industry experts and an extensive talks programme. The talks, which include several first-hand accounts from farmers, are split into three distinct streams: Energy in Agriculture, Smart Climate Land Use and Farm Diversification.



Recruitment Drive

In order to attract prospective Firefighters to the Fire Service, Tipperary Fire and Rescue Service have undertaken great efforts to promote and attract people to the sector. In the past number of months, firefighters from across the county have taken a more proactive approach to this. A number of 'Open nights' and 'Recruitment Days' across Tipperary were held, where Firefighters displayed their skills and answered any questions the public may have about joining the service. Firefighters in Clonmel and Tipperary Town also took to the streets handing out information packs and flyers. These efforts were matched by a social media campaign in conjunction with media interviews, career talks and attendance at a county careers expo held in Thurles earlier in the month. These efforts to date have yielded a number of applicants putting themselves forward for consideration.







Station Tours

Now is the time of year when we see a huge increase in demand for fire station tours. This is a fantastic way to connect with the communities we serve and to spread the 'Fire Safety' message. Where possible we will always try to facilitate these requests and are delighted to welcome schools back into our stations. We have also carried out a number of visits to preschools and are always delighted with the interaction from students and teachers alike. This year we are placing a special emphasis on the 'STOP, DROP and ROLL' technique and have even created a short original cartoon to demonstrate this.

It remains a priority for Tipperary Fire and Rescue Service to engage with the public in regard to all matters relating to Fire Safety, in doing this we as a community can reduce the risk and subsequent consequences of a fire occurring.





Transition Year Youth Fire Service Programme

Community Fire Safety has always been to the forefront of Tipperary Fire & Rescue Service, through our Community Smoke Alarm Scheme, our 3rd Class Primary Schools Programme and many more initiatives with which we strive to help our communities take a more active role in their own fire safety. While we have always been very active promoting Fire Safety at a primary school level there has, up to now, been less of an opportunity to do this at a secondary school level. Consequently, last year we launched the Youth Fire Service Programme. This is aimed at the secondary school senior cycle, primarily, but not limited to, transition years. This programme runs in conjunction with the secondary school curriculum covering areas such as Fire Science, Case Studies and even Career Investigation (where we look to the Fire Service for potential career opportunities). There is both a theoretical and practical element to the programme, which seems to appeal to all, both student and teacher alike.

At the end of this 4-week programme students will understand the basics of fire safety and their responsibilities both in and out of the workplace. They will also gain first-hand experience in dealing with small fires and extinguishers. In addition to this, students will obtain a certificate in Fire Marshal training which will be valid for 3 years and can be taken into industry.

Since the start of 2023 we have put more than 500 students from 5 secondary schools through the pilot stage of the Youth Fire Service Programme and all feedback has been very positive. Interest in the programme is also very high and many schools have already come forward to request that their school be considered for this programme next year.



- Tipperary Town Library held a gardening workshop with Siobhan O'Mahony on 19th May





Arts Service

A range of grants and schemes to support Arts Development in the county were awarded for 2023 as follows:

- Tipperary Arts Act Grant Scheme – intended to assist organisations in stimulating public interest in the arts, promoting the knowledge, appreciation and practice of the arts or in improving standards in the arts in the county. **35** groups were awarded funding to support artistic projects & events in 2023, the value of the support is €**38,350**.
- Tipperary Artist Awards intended to support professional artists under three categories, professional development, creation of new work, reaching audiences. 33 artists were awarded funding for 2023, the value of the support is €28,312.
- Tyrone Guthrie Centre Regional Bursary Scheme - two bursary awards were granted to professional artists living in Tipperary to develop work at the County Monaghan workplace for artists.
- Local Drama Scheme One drama group received support towards their development proposal to run a skills refresher course for their members.
- BLAS International Summer School of Traditional Irish Music & Dance.

Tipperary County Council advertised two bursaries to attend this year's summer school at the University of Limerick. The value of the bursary covers <u>1 week's tuition</u> (one-week intensive of masterclasses, Irish language, lectures and concerts). The purpose of these bursaries is to support professional development of artists.

 Artist in Primary School Scheme -The aim of this scheme is to give pupils in schools all over the county the opportunity to work with a professional artist on a once-off unique project to be originated and planned between the artist and the school. 12 schools were successful in receiving support under this scheme. Projects have commenced in Lackamore National School, Newtown Upper National School, Moycarkey NS and Lorrha National School. Please see images from the projects below.



year's programme included over 120 events across the county, a mix of workshops, live and online performance, exhibitions and socially engaged projects across a wide range of art forms including theatre, music, literature, film and visual arts. The festival was launched in Roscrea Library by Cllr. Roger Kennedy, Cathaoirleach with an event featuring participants of Age Friendly Roscrea. Working with artist/folklorist Michael Fortune they showcased their work and findings from their recent folklore and reminiscence project. Michael and the group exhibited this material as a pop-up exhibition featuring images, text and films which was available to view in the library for the month of May.

Nenagh Arts Centre celebrated Tipperary Bealtaine festival with a number of free workshops (exploring topics such as ageing creatively and learning about local history) as well as live music and theatre performances, culminating in a performance of the play Paddy goes to Petra', written and directed by Upperchurch theatre maker Áine Ryan, on Tues 30th May. The work of Cloughjordan artist Helen Costello also featured, with her Seen Unseen exhibition on display in the Arts Centre throughout the month of May.

• The Tudor Artisan Hub creative team presented a total of 6 workshops and demonstrations at the Sean Healy Library in Carrick on Suir, inviting participants to engage in their Mending Matters programme, and learn simple and practical skills to repair, repurpose and renew belongings.



 Artist Aoife Barrett takes her *Print Van Go* travelling studio to

 Katy Goodhue is a visual artist who lives and works in the Slieveardagh Hills and presented the Slieveardagh Recollection Collection at the Millennium Family resource Centre in Glengoole, an exhibition of items from a project where older members of the community come together to celebrate their collective and individual pasts.



• In Newport, artists Chelsea Canavan and Andy Spearpoint worked with Newport Day Care centre on *Sound Sight and Story*, a project where residents shared stories associated with items of personal significance to co-create artworks and soundscapes.



Aisling Fitzgerald and Joey Maguire led The Retracing Project with an aim to creatively engage older people with their childhood leisure memories through nature, art and heritage. Capturing stories and memories of Glengarra Wood and Mountain Lodge Burncourt, the project created a portal for social history to entwine with creative practice that engages with our natural and architectural heritage. Prompted by a reprinting of the original Nature Trail pamphlet of Glengarra Wood (courtesy of Galtee Honey Farm), a series of recorded interviews with senior citizens from the Galtee Vee Valley were featured, alongside woodland drone footage and interviews of retired foresters and former hikers, as part of a short documentary film. The Tipperary Bealtaine Music Tour is a centrepiece of the Tipperary Bealtaine offering each year, and this year professional musicians once again visited a number of day care centres, nursing homes and hospital settings- including Borrisokane Day Care Centre, St Conlon's Nenagh, as well as centres in Tipperary Town, Templemore, Thurles, Holycross and Cashel.

COMMERCIAL RATES

Rate Accruals for 2023 amounted to **€36,839,065.** This has been adjusted downwards in the amount of €55,080, following decisions on appeals to the Valuation Tribunal following ReVal 2019. Further reductions may follow as other appeals are decided.

Arrears of €5,921,516 were brought forward from 2022, giving the total amount to be collected as €42,705,501.

Receipts of €11,431,456, (27%), were recorded to 30/04/2023.

EARLY PAYMENT SCHEME FOR COMMERCIAL RATES

Approximately 3,850 (88%) of customers are eligible to benefit from our Early Payment Scheme in 2023.

If fully subscribed and availed of this could achieve total reductions in their rates of €653,680.

The terms for our Early Payment Scheme for 2023 are: -

- Applied to all rate payers with an annual rates bill of up to \pounds 26,000.
- To avail of the Early Payment Reduction of 6%, subject to a maximum of €600, payment of rates must be made in full, by 31st July 2023.
- Customers paying by Direct Debit can avail of the scheme if payment is made by September 2022.

The scheme is open to customers with arrears on their accounts where they meet the following requirements:

a) Pay a minimum amount which is equivalent to the annual rates by the same timelines outlined above and

b) Enter into a structured payment plan to address and eliminate arrears.

VACANT PROPERTY RELIEF

Commercial Rates remain payable on vacant property. Where a property is vacant on the date of making the rate, owners must notify the local authority and advise that the property is vacant and for letting, or is closed for refurbishment or repair.



Vacancy relief will be applied to qualifying property in accordance with the following scale:

Category	% Relief/Payment
Qualified Vacant Properties with a rates bill up to €5,000	100% Vacancy Relief
Qualified Vacant Properties with a rates bill over €5,000, but less than €10,000	80% Vacancy Relief 20% to be paid
Qualified Vacant Properties with a rates bill over €10,000	60% Vacancy Relief 40% to be paid
