#### MINUTES OF PROCEEDINGS OF THE NOVEMBER MEETING OF NENAGH MUNICIPAL DISTRICT HELD IN NENAGH MUNICIPAL DISTRICT CHAMBER AND via ZOOM AT 10.00 AM ON 16<sup>th</sup> NOVEMBER 2023

Item 1. To note any Disclosures/ Conflicts of Interest	None
Item 2. To consider and adopt Minutes of the October Meeting held on 19 <sup>th</sup> October 2023	It was proposed by Clir. Bonfield, seconded by Clir. Darcy and resolved that the minutes of the October Meeting held on 19 <sup>th</sup> October 2023 be adopted.
Item 3. To receive an update from Housing	The Housing report was circulated to members. Cllr. M. O'Meara complimented the work that was done on voids to date this year but asked if extra funding was going to be made available before the end of the year. He also stated that the Croí Conaithe scheme was very worthwhile. Cllr. Morris welcomed the proposal for the 67 houses in Tyone but was concerned with the length of time and complexity in getting housing schemes through the process. He is aware of people working who are getting notices to quit on their properties as landlords are leaving the sector. There are 166 using the homeless services but the report should reflect the number of people who have received NTQ and are engaging with the homeless service. Report also needs to show negotiations with landlords.
	Cllr. Bonfield thanked the Housing team for their work. She asked if it would be possible to get a breakdown of the numbers on the housing list to show how many are from HAP. The figure for housing applicants has been around 700 for the last number

of years and has not reduced significantly even though additional houses have been provided.
Cllr. Hannigan also commended the work on voids and the Croí Conaithe scheme and stated that everything should be done to ensure people avail of the different schemes available to them. He was concerned about the person in the middle whose income is too high for social housing but they cannot get a mortgage from a bank. It may be useful to highlight the Local Authority Loan and the areas that can cause issues in getting the application approved by the Department. 13 approvals from 68 applications is low but he acknowledged that a lot of work has to be done to get the application to approval stage. It may be worth going back to the Department explaining the areas that are causing difficulties.
Cllr. Darcy stated that any additional funding towards voids would be very welcome and that the Croí Conaithe scheme is a great opportunity for people.
Mr. S. Grogan explained that an application has been submitted for additional funding for voids and positive feedback has been received but Housing are currently waiting on written confirmation. Work can't begin until this has been received. The figures in relation to Notice to Quit will be included in the report going forward. The figure on homeless presentations is part of the Management Report for the full council. He will let Cllr. Bonfield know the figure for HAP on the housing list after the meeting. The number of applicants on the Housing list has been the same for the last number of years, more houses are being provided but more applications for social housing are also being received. In relation to the loan scheme Tipperary County Council have to stay within the National Framework. 13 loans have been issued and a lot of work has to be undertaken to get the loans to drawdown stage. Staff work with applicants to ensure the documentation is to the standard required and the Department approves the loan. Any feedback on the schemes is welcome and will be sent to the Department. Guidance can be put on the website for "Getting Mortgage ready" .
It was proposed by Cllr. Darcy and seconded by Cllr. Bonfield and resolved that in accordance with the terms of the 2023 Contribution to Clubs/Organisations Grant Scheme the payment of grant of $\in$ 800 be made to the Choose Respect Committee.

<ul> <li>Town and Village Renewal Scheme 2022</li> <li>Ballina Access Promenade and Viewing Area – Jennings O' Donovan, Consulting Engineers have commenced work on preparation of tender documentation for the work. As part of the conditions under the permission from An Bord Pleanála bat and otter surveys are required and this will involve the procurement of an ecologist for this purpose. An archaeologist will be required to carry out monitoring during construction. The consultant has been requested to provide a timeline for the procurement process.</li> <li>Newport Courthouse and Bridewell Complex – Scroope Design have been appointed to prepare a feasibility study. Engagement and consultation process have commenced and a meeting is being arranged between the consultant and the area planner.</li> </ul>
<ul> <li>Painting &amp; Enhancement Scheme 2023:</li> <li>Fifteen applications have currently been received to date under this scheme – thirteen applications received provisional approval; seven grants have been processed for payment; one of which was cancelled and the other five are awaiting completion of works/return of documentation; two applications were refused due to non-compliance with the conditions of the scheme.</li> </ul>
Casual Trading Bye Laws:
<ul> <li>Tipperary County Council (NMD) recently invited applications for casual trading licences for 2024 or part thereof. The deadline for receipt of completed application forms was 1<sup>st</sup> November. A total of 7 applications has been received i.e. 1 application for Castlelough, 2 for Garrykennedy, 3 for Ballina Riverside Park and 1 for Dromineer. Following assessment of</li> </ul>



these applications and receipt of the appropriate fee, licences in respect of successful applicants will be issued.

- During 2023 a total of 6 licences were issued i.e. 1 for Castlelough, 2 for Garrykennedy, 2 for Ballina Riverside Park and 1 for Dromineer. All of these licences will have expired by 31<sup>st</sup> December 2023.
- During 2023 contact was made with a number of parties in relation to the establishment of a working group to consider opportunities for developing a market in Nenagh. This will be further progressed in the near future.

# Expressions of Interests for Development Land at Lisbunny

Tipperary County Council advertised for expressions of interest from developers and entrepreneurs interested in acquiring a prime 19.2 acre industrially zoned site at Lisbunny Business Park, Dublin Road, Nenagh for immediate development and job creation. The closing date for expressions of interest was 4.30 pm on Friday 9<sup>th</sup> June 2023. Applicants who had expressed interest in the development land have been asked to provide more detailed proposals.

## **One Way System**

Detailed design on the Nenagh One Way System is currently being finalised. Advance works will start on Pearse Street on 16<sup>th</sup> November with full implementation likely in Q1 2024.

#### Nenagh Municipal District Awards Evening

The Nenagh Municipal District Awards evening will be held on Monday 20<sup>th</sup> November commencing at 6.30 p.m. in the Civic Offices, Nenagh. On the night various presentations will be made in recognition of special achievements and significant contributions to the community.

#### **Designated Bathing Area**

A public consultation meeting took place in Dromineer on Tuesday 14<sup>th</sup> November to discuss the proposed designation of Dromineer as a bathing area in accordance with the Bathing Water Directive. Proposals are currently being prepared by Destination Lough Derg Tourism Officer, Environment Section and Nenagh MD. The process commenced in 2022 with a submission to Tipperary County Council from Destination Lough Derg. A preliminary assessment was carried out by Tipperary County Council. Surveys were undertaken of visitor numbers and facilities. Environmental surveys are currently ongoing as is a Risk Assessment with Irish Water Safety. It is proposed to make an application to the EPA for official designation under the Bathing Water Regulations in March 2024 with a view to having a dedicated Bathing Area in place for summer 2024. Water quality will be monitored during the summer with the intent of securing blue flag beach status in 2025. 24 individuals attended the consultation. The application received unanimous support from

those in attendance with suggestions also being put forward for additional facilities. These will be considered and referred to the relevant agencies as appropriate.

## Pride of Place Winners

Nenagh was nominated by Tipperary County Council to represent Tipperary in the IPB Pride of Place Competition in the category for towns with a population of over 4,000 people. The Awards ceremony was held last Friday 10th November in Armagh. The event which is an all-island competition, recognises improvements made by local communities to create civic pride in their area. Nenagh won the Pride of Place award with the entry entitled 'We ♥ Nenagh'. This was a collaboration of Nenagh community representatives, co-ordinated by Nenagh Municipal District, the Silver Arch Family Resource Centre and Clúid Housing. The input of Ballygraigue Court Residents Association was a major factor in achieving this award.

### **Christmas in Nenagh**

- `Light Up Nenagh' will take place on Sunday 26<sup>th</sup> November with entertainment on the streets from 3 pm. There will be a partial closure of Pearse St. from the Market Cross to the junction with Kickham St. The Christmas Lights will be switched on at 5.30 p.m.
- This will be followed by the lighting of the Tree of Remembrance at Nenagh Courthouse at 6.15 p.m.
- 'Christmas at the Castle' will begin on the evening of 15<sup>th</sup> December and will continue on Saturday 16<sup>th</sup> & Sunday 17<sup>th</sup> December in Nenagh Castle, the Castle Field and the Castle Garden. Activities will include family entertainment, a market with stall holders and local vendors, an illuminated walking trail with lighting displays, projections, interactive elements and music. Entry is free. This event is aimed at making Nenagh a Christmas Destination. Santa Claus, Mrs. Claus and the Grinch will be based in Nenagh Castle on 16<sup>th</sup> & 17<sup>th</sup> December – booking through Nenagh Tourist Office.
- Other events which have been notified to us at this stage include:
  - Nenagh Christmas Tree Festival at St. Mary's Church of Ireland Nenagh from 13<sup>th</sup> to 17<sup>th</sup> December.
  - Ormond Octaves annual Christmas Concert at St. Mary's of the Rosary on Friday 15<sup>th</sup> December.
  - Panto 'Goldilocks and the Three Bears' at Nenagh Arts Centre on Saturday 16<sup>th</sup> December at 2 p.m.
  - Nenagh Christmas Tractors Saturday 23<sup>rd</sup> December at 6 p.m.

It was agreed that Cllr. Bonfield would represent the members on the Newport Town Team. It was agreed that Cllr. Morris would represent the members on the Nenagh Town Team. All the members expressed their congratulations on the winning of the Pride of Place competition.

To update members on	The update on the Works Programme was circulated to members.
Works Programme	Cllr. Bugler expressed her thanks for the work that is ongoing at Ballina Quay but was concerned about the condition of the R496 with the additional traffic the last 4 months, especially at Darcy's Bridge. She had a notice of motion down previously in relation to this.
	Cllr. O'Meara raised the issue of Ballingarry village. The residents are very upset, they believe the village has deteriorated and seems to be the most neglected village along the N52. He appealed to the executive to move Ballingarry to the top of the list but acknowledges that if the route was the responsibility of the Local Authority and not TII more work would have been done. Cllr. Darcy and Hannigan supported this. Cllr. Hannigan also raised the issue of the transport hub especially in the context of the new bus routes into town.
	Mr. M. O'Connor said it was not fair to say that Ballingarry has been neglected. When there was an issue at the Glue Pot this was rectified, the road surface is reasonable and the lights will be upgraded, a survey is currently being progressed. There is an area between the pub and the estate where the footpaths and lighting are poor and this will be looked at. The priorities for Ballingarry will be discussed at the meeting with TII on the 13 <sup>th</sup> December.
	In relation to the transport hub no significant progress has been made with NTA. No-one disagrees with the need for the transport hub, it was originally discussed about 8/10 years ago. Cllr. H. McGrath suggested that the side lane entrance be opened to provide inward access only to the railway station with exit at the roundabout.
	Cllr. O'Meara disagreed with Mr. M. O'Connor in relation to Ballingarry and wanted it at the top of the agenda for the meeting with TII.
	Cllr. J. McGrath complimented the work on the bridge in Templederry.
Item 7. To note	The Engineer's Checklist was circulated to members.
Engineer's Checklist on roads matters	Cllr. Darcy asked that Iarnród Éireann would be written to about the bridge at Ballygibbon. It is very dangerous and is impossible for pedestrians to use the road. The work at the bridge in Rathnaleen has not been done and he asked if something could be done with the sightlines at the cross on the Lahorna to Knigh Road.



	Cllr. Hannigan complimented the work on the Ballinderry to Borrisokane road but asked that the flooding issue near the cross and the footpath across from the Whiskey Still, Dromineer would be looked at. He also requested that the road surface in Terryglass village and signage for the harbour would be looked at.
	Cllr. O'Meara had submitted an email with the items for the checklist but wanted to include flooding near residential entrances on the Ballingarry to Aglish road and additional signage for concealed entrances on the R489 Birr to Portumna road. He doesn't think mirrors will solve the problem but that maybe a scheme for dangerous entrances could be developed.
	Cllr. H. McGrath requested that the exit from the Kenyon St carpark would be looked at as sometimes it is difficult to exit onto the road. Cllr. Bonfield asked that Pound St. Newport would be surveyed again.
	Mr. B. Murphy stated that he had looked at the railway bridge in Ballygibbon and has contacted Iarnród Éireann. The parapet at Rathnaleen was also checked and it is of sufficient height and no additional work is required. Surveys are done in rotation and the roads in Borrisokane will be surveyed again. The flooding issues and Kenyon St will be added to the checklist. Concealed entrances are a big problem and a lot are historic but he would not be in favour of erecting signage anywhere. The council cannot put up mirrors but won't object to anyone putting them up. For any new planning permissions there is a good policy in place but it is not easy to resolve those already in place. The surface in Terryglass will be checked but it is reasonable at the moment.

Notices of Motion	<b>Notice of Motion No: 2717 submitted by Cllr. F. Bonfield</b> That Tipperary County Council consider and work with the community of Newport in implementing an Active Travel Route from the GAA Grounds in Newport to the Soccer Field Facility (Derryleigh Park) in the town. It's an ideal project to implement an active travel route here because of the number of children that walk from the town to the facility and also because there is further expansion of the GAA facility on the cards following the purchase of a new playing field in the location also.
	Response was given to Cllr. Bonfield as follows:
	Derryleigh Park is located on the R503 Nenagh to Thurles Road. The facility is located 300 metres outside the speed limits of Newport town.

Orders Item 10.	Ms. R. Joyce informed members that Superintendent Baker had come back in relation to a new date for the Community Safety meeting. It was agreed to hold this meeting on Wednesday 22 <sup>nd</sup>
Item 9. To note Delegated Employees	Noted.
	Cllr. H. McGrath welcomed the response however he said there are a number of other crossings that could also be included.
	The draft Nenagh Local Transport Plan contains a number of interventions / improvements for Nenagh Town. Option AT18 identifies the creation of a segregated cycle route between the N52 Borrisokane Roundabout and Tescos' supermarket. The Council will develop a 'Safe Route to School Link' providing a connection from large residential areas off the Borrisokane Road to several schools in the area. The Brooklands pedestrian crossing will be upgraded as part of the AT18 scheme.
	<i>In 2022, the Council provided improved lighting and road markings at the pedestrian crossing at Brooklands as part of an Active Travel scheme.</i>
	Response was given to Cllr. H. McGrath as follows:
	Notice of Motion No: 2716 submitted by Clir. H. McGrath As we have now put in place raised pedestrian crossings on the new roundabout at the railway station I'm asking that we put in place a raised pedestrian crossings at Brooklands road outside IFAC building. This raised crossing would be of great benefit to pedestrians in the area.
	Notice of Motion 2716 was proposed by Cllr. H. McGrath and seconded by Cllr. Darcy.
	Cllr. Bonfield welcomed the response.
	A submission will be made to Active Travel for funding when a preliminary proposal is developed.
	It may be possible to extend a footpath along the local L6009 road in conjunction with a possible expansion of the Newport GAA grounds. This option can be examined in consultation with the GAA and soccer club.
	<i>Council policy is not to construct footpaths outside existing speed limits based primarily on safety reasons. Any footpath constructed along the R503 would require land purchase and installation of street lighting.</i>



November at 9.00 a.m. and that items for discussion would be submitted before the end of the week.
Cllr. O'Meara mentioned the recent break-ins in the Lorrha area. The public are angry but the work of the Gardaí is not an issue. The fact that Lorrha is in the same division as Ballyvaughan is not good enough. It would make more sense for Lorrha to be in the Birr or Portumna areas. Local knowledge is being passed to burglars and they are targeting isolated areas.
Cllr. Hannigan agreed that local knowledge is giving the information on where and when to target. Community Alert has to be re-established and Garda numbers are a concern. He enquired if it would be possible to get details of the current numbers in the force and at what level they should be at.
Cllr. Darcy stated that crime waves move from area to area and that every area will eventually be hit. It is really important that the Community Alert scheme gets back up and running. At the moment community knowledge is working against people. He has raised the issue at the JPC and would like it on the agenda for the meeting next week.
Ms. R. Joyce informed members that Brian Treacy, Waterways Ireland will meet members in January and she will contact them regarding dates but they should submit details of any items they want included on the agenda.
