




ROAD SAFETY

Road Safety Section undertook an extensive "Don't drink and drive" campaign in December 2023. Adverts, such as the following, appeared in all the local newspapers and on social media.

A radio campaign was also undertaken with Tipp FM, which ran from Christmas Eve until New Year's Day. This advert, which urged drivers to slow down, wear a seat belt and not to drink and drive, ran four times per day and received numerous presenter mentions throughout the day.







PUBLIC LIGHTING

Public lighting queries are dealt with daily by the Roads Section, the Customer Service Desk and the Municipal/Borough Districts. Enerveo is notified of the relevant queries and corrective action is taken as appropriate. Tipperary County Council has responsibility for the management and maintenance of more than 18,300 lights in the county and public lighting is the biggest user of energy in the Council's overall energy usage.

Tipperary County Council is participating in the National Public Lighting Energy Efficiency Project (PLEEP) which will see 11,600 lights upgraded to LED across Tipperary. This project is being rolled out on a regional basis with Tipperary County Council included in the Eastern region. Kilkenny County Council is leading the project in the region. Tipperary County Council continues to engage with the lead partner to ensure successful delivery of the project. The contractor appointed to carry out this work has completed surveying all existing streetlights and lighting designs will commence in early 2024.

EV CHARGING

Tipperary County Council in partnership with **EasyGo**, working with *eir*, are progressing with the installation of Electric Vehicle Chargers across Tipperary which will see the company investing €600,000 into the county. This involves the installation of thirteen new fast electric vehicle (EV)

charging stations in County Tipperary, providing 24 charging points.

EasyGo and eir have joined forces to develop new charging points across the country, to accommodate the growing number of EVs on our roads. Installing these chargers in easily accessible town centre locations will increase the appeal of EVs for drivers, greatly extending the accessibility of charging points and thus the range of the vehicles. Transport accounts for one-third of Ireland's energy-related CO2 emissions so increased adoption of EVs is a key aspect of Ireland's Climate Action Plan. <u>SALTING ROUTES –</u> <u>WINTER MAINTENANCE 2023-2024</u>

The winter maintenance period lasts from mid-October to the end of April each year. Tipperary County Council is constantly striving to improve its winter maintenance service; however, neither the local authority nor Transport Infrastructure Ireland (TII) (formerly the NRA) has a statutory obligation to pre-salt roads.

Having regard to the Council's resources in terms of finance, equipment and staffing levels and to maximise benefit to road users, winter maintenance of roads in Tipperary is prioritised on the following basis:

- Priority 1: M7 Motorway, M8 Motorway, National Roads, and Regional Roads of strategic importance, e.g. Expressway Bus routes, access to Train and Bus Depots, Hospitals, Ambulance routes, and Fire Stations.
- Priority 2: Regional Roads with high volume of traffic using the road and access to major schools and industries.
- Priority 3: Other regional roads, town streets and local county roads on a priority basis.
- (In extreme weather events Priority 1 routes will take precedence over Priority 2 routes in terms of allocation of available resources).
- The Council has quid pro quo agreements with Waterford, Offaly and Kilkenny County Councils to treat routes in each other's areas to increase efficiency of the treatment routes.
- The Council has a total capacity of approximately 3,880 tonnes in its salt storage facilities, which is sufficient to treat a 5-day snow event.

- Twelve crews are rostered to pre-salt
 Priority 1 and Priority 2 Routes (approx.
 1,010km) before the onset of icy conditions.
 These spreaders can have snowblades fitted in the event of snow.
- It is common for a variance in road temperatures to occur across the county, which may result in only some of the routes being pre-treated on any particular night.
- In the event of dangerous road conditions i.e. black ice, white frost, snow, flooding, muck or any other hazardous road condition, the responsibility is on the driver to drive at an appropriate speed with due care in accordance with prevailing conditions on the road.

Tipperary County Council is not responsible for any accidents that may occur as a result of poor driving conditions.

HEDGE CUTTING

The 2023/2024 Hedge cutting Season commenced on 1 September 2023 and runs through to 29 February 2024.

All landowners and occupiers of land are requested to note that Section 46 of the Wildlife (Amendment) Act, 2000 prohibits the cutting, burning or destruction of any vegetation growing on uncultivated land or in a hedge or ditch during the period 1 March to 31 August each year. This is to ensure the safety of birds and other wildlife.

Tipperary County Council would like to thank owners and occupiers of land adjoining roads who inspect trees and hedges on their property during the hedge-cutting season and ensure that they do not pose a danger to road users.



Examples of hazards include dead or dying trees, ditches or hedges interfering with traffic, blocking footpaths, obscuring road signs, public lighting or road users' visibility.

Tipperary County Council requests the co-operation of the public in keeping road users safe. A public awareness campaign commenced in September and will continue throughout the hedge-cutting season.

The Council's District offices will be carrying out local inspections and notices will be issued as necessary to relevant landowners.

NOTICE TO LANDOWNERS AND OCCUPIERS OF LAND ADJOINING PUBLIC ROADS

ROADS ACT 1993, SECTION 70 ROADSIDE TREES, DITCHES AND HEDGES FROM 1 SEPTEMBER 2023 UNTIL 29

FEBRUARY 2024

Tipperary County Council wishes to give notice that under the terms of the Roads Act, 1993, Landowners and occupiers of lands are obliged to take all reasonable care to ensure that the trees, ditches, hedges and other vegetation growing on their lands are not or could not become a danger to people using or working on a public road.

Examples of hazards include dead or dying trees, ditches or hedges interfering with traffic, blocking footpaths, obscuring road signs or obscuring the view of the road ahead. You are required to fell, cut, log, trim or remove such trees, ditches and hedges.

If you wish to advise Tipperary County Council of a structure, tree or hedge adjoining a public road which is considered to be dangerous, please contact the Customer Services Department:

URDF Call 3

URDF Call 3 seeks to tackle long term vacant and derelict buildings and sites across URDF towns and cities primarily in order to accelerate the provision of residential development and regenerate town centres. An allocation of €5m has been approved for Tipperary County Council under this Call and €1m of this allocation has been paid in advance to assist with early activity under an approved acquisition programme in the URDF designated towns of Clonmel, Nenagh and Thurles.



PLANNING SECTION

Local Area Plans for Clonmel, Nenagh, Thurles and Roscrea

With the Tipperary County Development Plan 2022-2028 now in place, progress on the preparation of Local Area Plans (LAPs) for the Key Towns and District Towns in the County is well advanced. The Tipperary County Development Plan 2022-2028 sets out a Core Strategy for the development of towns and villages in the County. The plan sets out the character, potential and vision for growth as demonstrated in the Town Profile Plan for Key and District Towns which will inform the preparation of a new Local Area Plan.

The Planning Section commenced the development of the Roscrea, Clonmel, Nenagh and Thurles LAPs in Autumn 2022 and have been developing each of the LAPs through the different stages of the process for adopting the Plans since that time.

In September 2023, elected members decided to make the Roscrea Local Area Plan 2024-2030. This Plan came into effect on 23 October 2023, replacing the Roscrea Local Area Plan 2012.

Draft LAPs were published on 28 July for the Clonmel, Nenagh and Thurles LAPs and the public display period ended on 11 September. 117 submissions were received on the Draft Clonmel LAP, 37 submissions on the Draft Nenagh LAP, and 27 submissions on the Draft Thurles LAP. Chief Executive Reports were prepared for each of the LAPs and provided to elected members, summarising each of the submissions received, and providing recommendations on addressing each of the submissions. On 27 October 2023, members decided to amend the Draft LAPs for each town in accordance with the recommendations of the Chief Executive Reports, with some minor additional amendments in the case of the Thurles LAP.

Proposed Material Alterations (PMA) to each of the three LAPs were published on Friday 17 November, with consultations closing on Monday, 18 December 2023 at 4pm. This is the final stage of public consultation. 21, 11 and 10 further submissions were received on the Draft Clonmel, Nenagh and Thurles LAPs respectively. Chief Executives Reports on the submissions received in the PMA stage were provided to all Elected Members on 19th January 2024. Workshops were held for the elected members of each respective municipal district in late January to discuss the relevant CE reports in advance of the plenary meeting on 12 February 2024. A decision whether to make the Local Area Plans will be made at a plenary meeting in February. If a decision is made to make the Local Area Plans, the Plans will have effect on 25 March 2024, and will replace the respective Town Developments Plans currently in place for each of the towns.

Residential Zoned Land Tax

The Residential Zoned Land Tax provisions of the Finance Act 2021 set out criteria to facilitate the identification of lands which fall within the scope of the tax. The Planning Authority are responsible for preparing and publishing maps based on this criteria. These maps are to be based on the local authority development plan and where relevant, local area plan zoning maps i.e. where land is zoned and suitable for residential development. The legislation also sets out certain lands which are to be excluded from the scope of the tax.



Final RZLT Maps for 2023 were published on 1st December 2023, taking account of determinations and appeal decisions made on Draft and Supplemental Map submissions, and any other relevant changes including changes on foot of the annual Uisce Éireann's WWTP capacity register and zoning changes that come into effect prior to 1st Nov 2023 with respect to the new Roscrea LAP 2023-2029. The Final Maps were published on the TCC website (https://www.tipperarycoco.ie/rzlt) on 1st December 2023.

It was announced in Budget 2024 that the RZLT would be deferred by 1 year. The tax was due to take effect from 1 February 2024. This means that the first liability date will instead be 1 February 2025 and will be charged annually from 1 February 2025 onwards.

A new public notice period for the 2024 RZLT was published on 1st February 2024. This recent announcement has had the effect that submissions on inclusion / exclusion and requests for zoning changes can again be made in the current public consultation. Anyone can make a submission either requesting a site to be included or requesting a site shown on the maps to be excluded, and also allowing landowners to request a zoning change to a site which is included on the RZLT maps. Submission which relate to inclusion / exclusion on the RZLT maps must be made by 1st April 2024. Submissions that relate to requests for zoning changes must be made no later than 31st May 2024.

The RZLT now relates to 18 towns/villages. Kilsheelan and Portroe have been excluded on foot of the most up to date Uisce Eireann WWTP capacity register. Newport, Ballina, Cloughjordan and Fethard continue to be excluded based on lack of capacity in the WWTPs. When respective WWTP upgrades are complete, these towns will be reviewed and considered in the context of updated Uisce Eireann Capacity registers.

Submissions can be made through the webpage or in writing to the Nenagh or Clonmel planning office.

Town Centre First (TCF) / Town Regeneration Officer (TRO)

Tipperary County Council was awarded funding earlier this year of €100,000 to deliver a Town Centre First Plan for Roscrea Town. The funding has been awarded under the Department of Rural and Community Affair's "Our Rural Future", Ireland's Rural Development Policy 2021-2025. The plan will help to develop Roscrea's own unique vision and plan for its future development and once complete, will provide a basis for the town to seek support from multiple funding streams, including the Rural Regeneration Development Fund, (RRDF) and the Town & Village Renewal Schemes. A Town Regeneration Officer was appointed in November by Tipperary County Council and will initially work



with Roscrea as the first pilot town in the County to have a TCF plan developed. The first steps will be to establish a Town Team for Roscrea for which expressions of interest were received as part of a public consultation process during the summer. A contract will be awarded shortly to appoint consultants to support the delivery of the Town Centre First Plan with the TRO and a timeframe for completion has been set for the summer of 2023.

Urban and Rural Regeneration and Development Fund: Project Implementation

The National Development Plan (NDP) 2018-2027 established four new funds to help drive the specific core priorities detailed in the NPF (National Planning Framework). These four funds included an Urban Regeneration and Development Fund administered by the Department of Housing, Planning and Local Government and the Rural Regeneration and Development Fund administered by the Department of Rural and Community Development. The following projects are currently being delivered.

Clonmel 2030 Transformational Regeneration seeks to develop a multi-dimensional, public/private/community partnership proposal for Clonmel, which will re-imagine how civic, cultural, educational, enterprise and tourism uses can work together to regenerate and create a new role for the town. The project includes four intrinsically linked and integrated pillars, namely: Kickham Barracks Regeneration, Clonmel Regional Sports Hub, Clonmel − Flights of Discovery and Clonmel Public Realm Enhancement. Funding was received for proposed Category A works in 2019 relating to Kickham Barracks Regeneration Phase 1 and Clonmel Regional Sports Hub. Both elements of the project are completed. Total project costs approved are €15,163,247 and URDF grant awarded is €10,594,961.


Liberty Square Enhancement Scheme, Thurles seeks to deliver a vibrant Liberty Square at the heart of Thurles: a place to live, shop, work, socialise, play or "hang-out". The revitalised Liberty Square will become an engine for growth in and around Liberty Square and will enhance the attractiveness of Thurles as a place to live and a place for investment / employment. Funding was received in 2019 to undertake works to the Eastern end of Liberty Square and to develop a new car park off Liberty Square. Additional funding of €1m was secured in March, 2021 to undertake enhancement works to



the Western end of Liberty Square and the junctions of the approach roads. The new car park and works to the Eastern end of Liberty Square are fully completed. The Project Management Plan for the delivery and implementation of the next phase of this project is ongoing. **Total project costs** approved are €10,700,291 and URDF grant awarded amounts to €5,390,291.

A Pathway to a Low-Carbon Society: A Centre of Excellence for Sustainable Energy driving the transformational urban regeneration of Nenagh: -The proposal is to develop a Centre of Excellence for Sustainable Energy, to be the anchor and catalyst for the redevelopment of Martyr's Road Regeneration Quarter, a 10 ha. strategic site of brownfield lands and underutilised properties located in the heart of Nenagh Town Centre. The Centre of Excellence, taking reference from best international practice, will uniquely host a range of public agencies working collaboratively to deliver innovative solutions from training and development, to new cutting-edge research on technologies, to incubating low-carbon social enterprises. The Centre has been designed to be Ireland's first carbon neutral and energy positive building. The works to be supported also include Public Realm and Amenity Enhancement to Friar Street Civic Plaza, Martyr's Road Town Park, Martyr's Road streetscape improvements, including cycleways. Funding was approved in March, 2021 under the Second Call for funding support from the Urban Regeneration Development Fund. The Project Management Plan for the delivery and implementation of this project is ongoing. Total project costs approved are €12,700,000 and URDF grant awarded amounts to €9,525,000.








Sustainable Energy Centre of Excellence, Nenagh

Tipperary Town Regeneration - This is regarded as a significant regeneration project for Tipperary Town which will greatly enhance long term sustainable tourism for the area. It includes: Upgrade of the Market Yard as a pedestrian priority area linking the Excel Heritage Centre to Market Yard and the Town Centre; Development of an 800m gravelled walkway parallel with the existing river channel and connecting to the existing path near Glenview; Installation of a new pedestrian bridge to access the walkway from the Link Road. Funding was approved in 2018 under the Rural Regeneration Development Fund. All elements of this project are completed. Total project costs approved are €1,442,018 and RRDF grant amounts to €1,081,513.00.

Fethard Town Park

The project consisted of the development of a community sport and recreational campus, incorporating a community pavilion, playing pitches, stand, walkways, parkland and open spaces. The project was developed through a partnership approach with Coolmore Ireland, Cashel and Emly Diocese and Healthy Ireland. Funding was approved in 2019 under the Rural Regeneration Development Fund. This project was completed in early April, 2023 and opened to the public on 8th. April. The official opening was undertaken by Minister Heather Humphreys on Sunday, 18th. June, 2023. Phases 1 and 2b groundworks and pitches together with the stand and community annex of the pavilion were funded by the Magnier Foundation (Coolmore Ireland). **Total project costs for Phase 2A Pavilion and Public Realm Works amounted to €3,145,314 and RRDF grant amounted to €3,003,445.**


The project proposal is a flagship urban regeneration project to conserve and establish Templemore Town Hall as an economic, cultural and community hub of the town, the District and the Mid-West Region. The project was prepared by the Council in partnership with the Garda Training College, Templemore College of Further Education, Templemore Community Development Association, the Local Enterprise Office and Tipperary Energy Agency. Funding was approved in 2019 under the Rural Regeneration Development Fund. The Project Management Plan for the delivery and implementation of this project is ongoing. **Total project costs approved are €4,014,746 and RRDF grant amounts to €3,011,060.**

Nenagh Historic & Cultural Quarter - A Tourism-led Regeneration Plan

It comprises a Plan to regenerate specific existing buildings and civic spaces of distinction and value within Nenagh (including The Gaol, The Castle and Banba Square) to stimulate tourism growth and revitalise the local economy/visitor economy within a context of tourism-led regeneration, comprising arts, history, heritage and culture. The focus will be on the development of 3 Flagship Pillars and 3 Supporting Pillars, collectively offering an immersive tourism experience. Funding was approved in 2020 under the Rural Regeneration Development Fund. The Project Management Plan for the delivery and implementation of this project is ongoing. **Total project costs approved are €896,712 and RRDF grant amounts to €672,534.**

Carrick on Suir Regeneration Plan - Category 2 Project

Plan for the town, through investment in orientation and public realm enhancement actions, to build on its relationship and synergies with the Suir Blueway (west) and the historic Ormond Castle Quarter (east) and thereby regenerate the town centre as an immersive visitor destination and rural town in its own right. Funding was approved in 2020 under the Rural Regeneration Development Fund. This Category 2 project is completed. **Total project costs approved are €487,500 and RRDF grant amounts to €365,625.**

A Pathway to the Regeneration of Cahir Town Centre: Re-establishing the Historic Square as the Living-Working Quarter

A suite of measures that will re-vitalise Cahir's historic Square as a living-working quarter. The project will provide a dynamic town centre Square with a focus on pedestrian priority and civic space. The redevelopment will be focused around Market House, a flagship Business Development Centre based in one of the most historic buildings on the Square. Funding was approved in 2020 under the Rural Regeneration Development Fund. This category 2 project is completed. **Total project costs approved are €986,354 and RRDF grant amounts to €663,362.**

Thurles Market Quarter: Regeneration through Recreation, Education and support for Local Producers is a collaboration between Tipperary County Council, Thurles Lion's Club and Mary Immaculate College Thurles. The project will provide a designated market space in the town centre

for local food and craft producers, artists and performers and will offer a location in the centre of a cluster of civic spaces to be enjoyed by locals and visitors alike. The project was awarded RRDF Funding in April, 2021. The Project Management Plan for the delivery and implementation of this project is ongoing. **Total project costs are €3,825,700 and RRDF grant amounts to €3,443,130.**



Kilsheelan – Revitalisation of Rural Villages: A Model for Cluster Housing and Low Carbon Planning The all-in costs for this particular project have proven prohibitive and do not represent good value for money for the Council to proceed with the development. The Council is fully committed to working with landowners on the implementation of the cluster development guidelines on other suitable sites within the County in an effort to address population decline, breathe life back into our villages and ensure their viability into the future.

Rialto Digital & Enterprise Hub, Nenagh

Funding has been approved to prepare detailed designs and planning for the adaptive re-use of the former iconic 1940's Rialto cinema into a modern digital and enterprise hub facility using best practice and appropriate modern architectural intervention to provide excellent office, collaboration and meeting spaces. The associated brownfield site will be master-planned to explore the potential for further digital and enterprise office space, the creation of a new streetscape along Emmet Place, the potential provision of town centre residential units and the delivery of a new public amenity heart in the town centre. The Hub will be an exemplar sustainable, green, town centre regeneration project that will revitalize the town centre of Nenagh through the provision of much needed incubator enterprise space, public realm enhancement, improved permeability/linkages with existing streets and backland/infill development through planning for the delivery of town centre homes. The overarching aim and purpose of the proposal is to promote economic development and increase employment opportunities while preserving and saving a protected historic structure which was purchased by the Council in December,2020. The project was awarded RRDF Funding in January, 2022. The Project Management Plan for the delivery and implementation of this project is ongoing. Total project costs are €1,511,059 and RRDF grant amounts to €1,208,847.





Proposed Rialto Digital & Enterprise Hub

Carrick-on-Suir Regeneration Plan - 'A Journey from the Suir Blueway to the Ormond Castle Quarter - Delivering Our Community's Ambition'

This project follows on from the successful Category 2 RRDF application for the planning and design of extensive public realm enhancements in the town centre, development of Suir Blueway linkages and the regeneration of the Ormond Castle Quarter. Improvements will consist of (i) the transformation of Main Street, Sean Kelly Square, Greystone Street, Ball Alley Street and Chapel Street through the installation of high-quality public realm; (ii) provision of a new Enterprise and Digital Hub in a vacant town centre building owned by An Post on Main Street which will be managed and operated by Carrick on Suir Tourism and Economic Development Committee; (iii) the creation of an arrival point at Sean Healy Park through design, enhancment and orientation measures incorporating user needs for kayakers, cyclists, walkers and other users and the integration of the Suir Blueway Tipperary into the town centre through the creation of shared spaces along the Quays and linkages to Main Street.; (iv) public realm upgrade of Castle Street and repurposing of Ormond Castle Park as a high-quality Amenity and Biodiversity Park. The Project Management Plan for the delivery and implementation of this project is ongoing. Total project costs amount to €17,989,387. RRDF grant approved is €14,391,509.





Activating Cahir's Town Centre Regeneration Strategy This project follows on from the successful Category 2 RRDF application for the planning and design of a new Business Development Centre in the heart of Cahir, public realm enhancements in the centre of the town and the development of a car park on a central backland site. Improvements will consist of (i) the restoration and redevelopment of the vacant Cahir Market House and former Council Offices into a Business

Development Centre which will be run by Cahir Development Association and provide offices, a large training and conference room, co-working spaces and hot desks to satisfy the unmet demand in the town (ii) the refurbishment of the historic Granary building to provide a state-of -the-art library for the community; (iii) Cahir Square Public Realm Enhancements to include the recalibration of the traffic




circulating around the Square to a more rationalised flow that prioritises pedestrian and cyclist movements and the redistribution of public realm in favour of recreational space; (iv) the provision of a new car park consisting of 86 car parking spaces, coach parking, EV charging, and bicycle parking on disused backlands off Church Street which will involve the demolition of two derelict vacant buildings that were acquired by the Council under the Category 2 approved project. The Project Management Plan for the delivery and implementation of this project is ongoing. **Total project costs amount to €14,894,686. RRDF grant approved is €11,915,749.**

Reimaging and Regenerating Gantly Street – Towards an Age Friendly Neighbourhood for Roscrea This project will deliver a transformational change to the public space around Gantly Road and promote regeneration of town centre brownfield land through the activation of the surrounding lands. The project will be the catalyst and first phase in the implementation of the Gantly Street Age



Friendly Neighbourhood, an ambitious masterplan to create a more vibrant and appealing place for people of all ages to address specific social, environmental and economic challenges within the community. The works will involve (i) the realignment of Gantly Street to provide for improved pedestrian and cycle infrastructure in accordance with Age Friendly principles; (ii) the creation of high-quality public realm areas and footpaths; (iii) extensive bio-retention rain gardens and (iv) the provision of water

service and utilities infrastructure to service the Gantly Road Age Friendly Masterplan area. The regeneration and re-imaging of Gantly Street is critical to the overall delivery of the Gantly Street Age Friendly Neighbourhood masterplan area into the future. Development of the Gantly Street





masterplan area will transform a central area of Roscrea, create opportunities to provide homes, business and amenity space for local residents to enjoy and lead to knock-on socio-economic benefits for the whole of the town. The Project Management Plan for the delivery and implementation of this project is ongoing. **Total project costs amount to €5,639,145. RRDF grant approved is €4,511,316.**

Conservation Grant Schemes 2024

The **Built Heritage Investment Scheme 2024** seeks to encourage conservation of structures protected under the Planning and Development Act 2000 (as amended) and in certain cases, structures within Architectural Conservation Areas. The scheme also seeks to support the employment of skilled and experienced conservation professionals, craft workers and trades people. Funding is available for successful projects (the minimum amount is €2,500 up to a maximum amount is €15,000 per application) subject to each owner fully matching the funding awarded.

The allocation for Tipperary County Council under the scheme for 2024 is €126,400. This year Tipperary County Council also received an extra allocation of €30,341 under the supplementary ringfenced funding for historic thatched structures.

We received 42 applications under the scheme for 2024. The closing date was the 22nd January, 2024. All applications are currently with Michael O'Boyle, RIAI Grade 1 Conservation Architect, who will carry out a thorough assessment. The recommended projects will then be forwarded to the Department of Housing, Local Government & Heritage for approval or otherwise. Successful applicants will be awarded grants ranging from €2,500 to €15,000.

Letters will then issue to all applicants outlining any special conditions that need to be met under the terms of the scheme. Once applicants accept the terms and conditions they may commence work on their project. All works will be assessed and inspections carried out during the coming months. Works must be completed by the middle of September so the projects can be inspected and grants paid out.


The **Historic Structure Fund 2024** seeks to support conservation works to heritage structures in both private and public ownership. Tipperary County Council received 19 applications under the various streams for the scheme. These applications are also with Michael O'Boyle, RIAI Grade 1 Conservation Architect, to carry out a thorough assessment and in turn Tipperary County Council will forward short listed applications to the Department of Housing, Local Government & Heritage for their consideration. They in turn will advise us of the successful applications.



Social Media

To date both a Facebook page and Twitter account has been set up for Tipperary Fire & Rescue Service and are working extremely well with approximately 16,464. followers on Facebook and 1,848 on X (formally Twitter).

The 'Test it Tuesday' campaign continues to encourage people to test their smoke alarms every Tuesday. Our biggest 'Test It Tuesday' reach in one week reached over 3,200 followers but



averages approximately 2,550 per/week. To enhance this campaign TFS also created new online content utilizing a short video showing the public how to test their alarm we are also using an outside projector with a test-it-Tuesday message in Clonmel Fire Station which can be seen at night, to encourage people to test their alarms weekly.

The accumulative reach of all posts in 2023 was just over **1.4 million**. Our biggest post of the year reached 130,000 people and was engaged with over 30,000 times across X and Facebook. Social Media continues to be an important means of spreading both the fire safety and road safety messages. During the industrial action, we used these platforms to engage with the public to reassure them and to advise them to continue to call 999/112 for help if they required it.

A brief summary of our social media statistics are as follows:

- 18,312 followers of our Tipperary Fire and Rescue social media platforms. An increase of just under 300 followers from this time last year.
- Posts covered both fire safety/ /fire calls/traffic issues and general fire notices/ water awareness/ public advice...
- Over 8450 'followers are located in County Tipperary and 13,648 in Ireland This figure is a minimum as some Facebook users don't declare the town, county or country they live in.
- We had a reach of 234,158 over the course of the year,
- Our most viewed facebook 'post' reached 130,000 (approx.), safety notice and our most viewed X (formally Twitter) post (condolences to the victims of an RTC) was viewed over 13,000 times
- Our Facebook page was visited 26,000 times- giving us a huge reach.
- Our 'Test It Tuesday' campaign reaches an average of just under 2550 Facebook users' p/week.
- Tipperary Fire Service continues to be the most followed/liked Retained Irish Fire Service page on Facebook and ranks as the 3rd most followed Fire Service in the Country, ranking only behind Dublin and Cork.







- Tyrone Guthrie Centre Regional Bursary Award - Tipperary County Council will fund two bursary awards to professional artists living in Tipperary to develop work at the County Monaghan workplace for artists.

- Closing date for above 3 schemes is Thursday 29th February 2024 at 12 noon.
- The Arts Office also co-ordinates the Tipperary Festivals & Events Scheme on behalf of Tipperary County Council which supports festivals throughout the county. The closing date for 2024 is Wednesday 14th February at 12 noon.



Supporting Artists:

- Professional development training and events, in addition to supporting artists development, also provide important networking opportunities for artists in Tipperary and is an area of arts office support consistently identified by artists as of value. This spring we continue our online training provision in partnership with Visual Artists Ireland and partner local authorities in Limerick and Clare.
- Visual Artists Ireland serves as the representative body for professional visual artists in Ireland. As part of this partnership programme a webinar titled 'An Artists Guide to accessing Funding' will be presented on Thursday, January 25th. The session, facilitated by Marianne O'Kane Boal, will take a closer look at all things 'Funding and applications' with free access granted



to artists living and working in Tipperary, Limerick and Clare. Marianne O'Kane Boal, a renowned curator and writer specializing in art and architecture, will delve into various aspects of funding and application processes during the session.

Tipperary Bealtaine 2024 Open Call

In December 2023, Tipperary Arts Office issued an open call to artists based in County Tipperary to submit a proposal for an engagement project or event targeted at older people, culminating in a showcase during the month of May as part of the Tipperary Bealtaine Festival. Each year in the month of May, Bealtaine is presented as a nationwide festival celebrating the arts and creativity as we age. Tipperary Arts Office together with colleagues in the Library Service present an extensive, interactive programme throughout the county. The open call, which closed in January, attracted a significant number of high-quality proposals resulting in the successful approval of funding for seven projects. A total of 11 artists based in Tipperary, representing various art forms will lead projects for Tipperary Bealtaine 2024.

• The Tipperary Arts Strategy 2023-207 identified a need to create new opportunities to facilitate "networking and collaboration opportunities for artists" and to seek support for the "development of new work by Tipperary practitioners (particularly in the area of theatre)". We are delighted to work with the Irish Theatre Institute (ITI) as a partner on an initiative which supports playwrights and theatre makers called Six in the Attic and Virtual Attic 2023/24.

Six in the Attic (SITA) is a year-long artist development programme. SITA supports a community of playwrights and theatre makers to engage, explore, develop, debate, and collaborate on their projects and practice, both in-person and online.

Selection for the programme was made by open call published in October 2023. This year marks a new partnership approach with Tipperary Arts Office, Galway City Arts Office, Leitrim Arts Office, Roscommon Arts Centre and Wexford Arts Office. One artist from each of these counties was selected for SITA 2023/24.

The Six in the Attic & Virtual Attic Artists for the 2023/24 programme were announced in December and we are delighted that Áine Ryan was selected as the Tipperary artist participating in this inaugural year.

- The Biodiversity Office supported a Hedgerows Ireland event in Cashel on 13th January. This was a very well event with received 120 attendance.
- The Biodiversity Officer attended the 4thof the National Biodiversity Action Plan (2023-2027) in the Botanic Gardens on 25th January. Following this launch, Tipperary County Council will now begin the process of producing the County Biodiversity Action Plan (2025-2030).
- We are currently preparing grant applications for the Local Biodiversity Action Fund (LBAF) and the Heritage Council Grant Scheme. In 2024 these schemes will provide up to €116,000 of funding to support biodiversity projects and the creation of the Biodiversity Action Plan in County Tipperary.

COMMERCIAL RATES

As at 30/11/2023 Rate Accruals for 2023 amounted to €36,499,444.

Arrears of €5,921,516 were brought forward from 2022, giving the total amount to be collected as €42,420,960.

This has been adjusted downwards in the amount of €1,048,069, following decisions on appeals to the Valuation Tribunal following ReVal 2019. Further reductions may follow as other appeals are decided.

Write offs in the amount of €898,046 have been processed to end November 2023.

Receipts of $\[\le 32,262,841, (80\%) \]$, were recorded to 31/11/2023.

VACANT PROPERTY RELIEF

Commercial Rates remain payable on vacant property. Where a property is vacant on the date of making the rate, owners must notify the local authority and advise that the property is vacant and for letting, or is closed for refurbishment or repair.

Vacancy relief will be applied to qualifying property in accordance with the following scale:

Category	% Relief/Payment
Qualified Vacant Properties with a rates bill up to €5,000	100% Vacancy Relief
Qualified Vacant Properties with a rates bill over €5,000, but less than €10,000	80% Vacancy Relief 20% to be paid
Qualified Vacant Properties with a rates bill over €10,000	60% Vacancy Relief 40% to be paid
