Mr. Anselm McGowan, District Administrator, commenced the meeting with the meeting prayer as Gaeilge in recognition of Seachtain na Gaeilge. The Cathaoirleach, Councillor Declan Burgess, welcomed everyone to the March Municipal District meeting and commenced the meeting.

1.1 Disclosures/Conflicts of Interest

There were no matters notified to the Meetings Administrator.

2.1 Minutes of February Meeting of Tipperary-Cahir-Cashel Municipal District held on 26th February, 2024

The minutes of the Tipperary-Cahir-Cashel Municipal District February meeting held on 26th February, 2024 were adopted on the proposition of Councillor John Crosse seconded by Councillor Andy Moloney.

Matters arising from the minutes

Councillor Marie Murphy requested an update in relation to the number of demountable/derelict properties listed on last month's vacant houses report. Mr. Robert Johnston confirmed that this category also includes new acquisitions categorised as 'Other'. Therefore, there were a number of Buy and Renew properties, 3 halting sites, 2 demountables and the new build properties in Donohill which made up the 19 classed as 'Other'.

The Cathaoirleach wanted to congratulate the three towns who had very successful St Patrick Weekends. He also wanted to thank Councillor Michael FitzGerald and acknowledged his successful trip to Nottingham for St Patricks Day. And he wanted to particularly acknowledge the work of the Municipal District, Michael Begley and Councillor Anne Marie Ryan (Shiner) who had a strong role to play in bringing the Marching Mizzou Band to Tipperary Town. It showcased Tipperary in a positive way demonstrating a vibrant and an energetic parade.

Councillor FitzGerald advised that the Nottingham St Patrick Day Committee pick a County each year to invite and this year it was Tipperary. The Cathaoirleach and the Leas Chathaoirleach had other commitments and he was delighted to be asked to represent County Tipperary. He met a number of diaspora from Tipperary who were so proud to be at the St Patricks Day celebrations in Nottingham. Councillor Ryan (Shiner) thanked the Cathaoirleach for the acknowledgement and noted that it was a collaborative approach and thanked Tipperary Racecourse and Canon Hayes Recreation Centre who provided their facilities and demonstrated great community spirit.

3.5 Housing Directorate Report

The Cathaoirleach welcomed Cora Morrissey, Senior Executive Officer, Shane Grogan, A/Senior Executive Officer and Robert Johnston, Senior Executive Engineer, Housing Section to the meeting. Ms. Morrissey thanked the Cathaoirleach and was available to take questions from the Members.

Councillor McGrath referred to the housing development at Farmhallessy and asked for the breakdown of house types. She also requested an update on the Energy Efficient Retrofit Programme and regarding the affordable sites in Boherlahan she asked how does a developer with a land bank engage. Councillor Hanna Hourigan requested an update in relation to the grant funding for upgrading houses for older people or people with disabilities. Councillor Murphy asked when will the new housing development in Clogheen go to tender and also when will the contractor be on site in Mountain View Cahir. She also requested further details in relation to the Retrofit Scheme and asked how many of the 120 houses surveyed are in this District. Councillor Ryan (Shiner) asked would the Housing Section consider purchasing 6-8 of the vacant houses in Kilfeacle which Councillor Burgess acknowledged that the Respond are in good condition. development will be allocated on a phased basis which is a proactive approach and he hoped it would be mirrored on the Tuath development on the Clonmel Road. He thanked the housing team for the delivery of Aengus Court which is the first Council led development in Cashel in 2 decades and the tenants were delighted to receive the keys. However, he has concerns regarding the ramps at the roundabout because drivers are going to the middle of the road to avoid them. Councillor Kennedy also supported this and noted that the tenants are delighted with the tenancies. He also noted that the increased allocations of 15-25 every two weeks demonstrates real progress including the 6 Focus Ireland tenancy's for Irish House.

In response Ms. Morrissey confirmed that pre-tenancy training has been completed for the 6 Irish House tenants and they are waiting for their new house grant and should be moving in in a week. Mr Johnston confirmed that 150 properties were surveyed under the Retrofit Program and 29 are in this District including Market Yard, Cahir and Spafield, Cashel, however they are facing challenges with the programme. Clogheen and Mountain View are due to be completed in 2026 therefore it is hoped the contractor be on site in 2025. Mr Johnston confirmed that the Housing Section, previously contacted the owner of

the houses in Kilfeacle and they were advised that the houses are not for sale. Regarding Councillor Burgess proposal the Housing Section does engage with AHB and allocations would be phased if possible, however due to the design of some developments it is not always possible. He also confirmed that buttons ramps are the recommended option to accommodate HGVs and buses on regional roads and he will check if the roundabout has been built to spec. He confirmed that the Farranlahassery development comprising of 10, 1 bed, 15, 2 beds, 20 3, beds and 3, 4 beds.

Mr Grogan confirmed that under the Ready to Build Scheme the Council are providing service sites and the housing section are continuously looking to engage with developers who have planning permission in place. A dedicated email is in for interested affordable AffordableHousing@tipperarycoco.ie. In relation to Housing Grants the section is currently putting together a work programme. Councillor Burgess requested that a Ready to Build clinic would be set up to help anyone who is interested in the sites in Boherlahan and advised that the Community Hall could be made available. Mr Grogan confirmed that the Council has received 15 applications so far and if required they will consider an information session in the coming weeks. Councillor Hanna Hourigan sought an update in relation to Glen Court and the possibility of Housing purchasing some of the houses. Councillor FitzGerald advised that the Council have two houses in Kilfeacle and a further two were offered to the Housing Section and the owner was advised that there is no demand. Councillor McGrath confirmed that she previously raised about vacant houses in Goatenbridge and was informed that Goatenbridge isn't listed as an area of preference, however this should no longer be an obstacle with CBL. Councillor Moloney advised that the houses in Goatenbridge were built on zoned land and within a few miles there is a demand for 55 houses and people are needed to sustain the community. Mr Johnston confirmed that the District may be in a better position to answer any questions in relation to Glen Court.

The Cathaoirleach thanked the Housing Team.

3.1 Planning Directorate Report

The Cathaoirleach welcomed Ms. Caroline Conway, Senior Executive Planner and Mr. Kieran Ladden, Senior Executive Engineer, Planning Section, to the meeting. Ms. Conway thanked the Cathaoirleach and referred to the report circulated with the agenda and was available to answer questions.

Councillor Crosse requested an update in relation to the DPIs and in particular An Cuirt, Monard and Dun n'Or, Donaskeigh. Councillor Moloney referred again to the development of 48 houses at Dun Uisce and advised that the application for taking in charge was lodged in April, 2021. Councillor Ryan (Shiner) requested an update in relation to Glen Court, Emly. Councillor Burgess also referred to the DPIs and in particular The Steeples, Ashwell Hills, Deerpark Close because the residents are anxious to see progress. He also requested an update on the LAP

for Cashel and asked when will the engagement commence with the Municipal District and the Chamber of Commerce. Councillor FitzGerald requested an update in relation to pre planning particularly face to face meetings and on site meetings. He also referred to anonymous objectors and advised that anyone who wishes to comment should be required to provide their name.

In response, Mr. Ladden confirmed that he has met with the developer of the Steeples, Cashel and they are in a position to resolve the outstanding issues as part of a planning application which will be lodged in 4 to 6 months. He confirmed that Ashwell Hills is not a housing estate but a series of one off houses. In relation to Dun Uisce he confirmed that this is an active site and they are using the spine road for construction traffic. He confirmed that this is a developer led application and the developer responsible should be responsible for fixing any defects. Therefore, that section of road will have to be removed and re-laid. In relation to DPIs there has been a lot of engagement with the Department and they are waiting for the new policy document. He confirmed that Pairc Ard, Newcastle and Cloughjordan are approved in principal. He confirmed that a number of workshops have been held with Uisce Eireann regarding Glen Court and also a number of workshops internally with the Municipal District and Housing. As a result, Uisce Eireann have issued a no objection to taking in charge and the Site Resolution Plan will be advertised shortly. Councillor Hanna Hourigan and Councillor Ryan (Shiner) thanked Mr. Ladden.

Ms. Conway confirmed that the LAP for Tipperary Town and Cashel are at predraft stage. The draft is due to be ready in summer 2024 and Fergal O'Donnell in Nenagh is working on it. She confirmed that preplanning clinics recommenced. Applicants are invited to attend and if required, subsequently have a one to one meeting with a planner. She also confirmed that if there is a requirement for an onsite meeting this can also be facilitated. Meetings are facilitated on the phone, in person or via zoom. In relation to observations there are regulations in place which outline what constitutes a valid submission and any invalid submissions are returned.

Councillor McGrath welcomed the news in relation to Glen Court and Pairc Ard in Newcastle, however noted that any upgrade is a long way down the list. She also confirmed that she attended a preplanning clinic last week and noted that it was really well run and it was great that the clinics were back. Councillor Crosse expressed his disappointment that the DPIs were not moving and requested that we write to the Department to seek a resolution. Councillor Burgess seconded this and noted that this request will have to go to the CPG.

The Cathaoirleach thanked the Planning Section staff.

3.7 District Administrator's Report

The District Administrator's Report was circulated to the Members with the agenda and the District Administrative advised that he was available to take questions.

Councillor Moloney referred to the EV charging point in Cahir and highlighted that there is an €8.00 penalty for anyone that stays over an hour and it would be important that the public are made aware of this. Councillor Ryan (Shiner) requested an update on the Easy Go charging points in Tipperary town and the Tipperary to Limerick Junction walkway. Councillor Burgess requested an update in relation to the Interpretive Centre and also if a decision has been made on the Cashel Town Park funding applications made under Town and Village Renewal and ORIS.

In response the District Administrator advised that the EV charger had been installed by Easy Go and he would liaise with Michael Tierney who is the point of contact. He confirmed that he would also provide an update in relation to the Abbey Street installation. He has no update regarding the Interpretive Centre. Mr Frank Cussen confirmed that Robin Lee Architects are working on the tender documents for the library. He confirmed that EIR has commenced work on the N24 and the District is working in tandem with EIR and the project should be completed in the next month to 6 weeks. He also confirmed that a decision is due on the grant applications at the end of April.

3.7 District Engineer's Report

Mr Richard Power, Executive Engineer advised the Members that he is available for questions.

Councillor Ryan (Shiner) requested an update on the Red Roads funding. Councillor Burgess referred to the ramp at Boherclough Street and if the road at Carrow, Dundrum could be considered as part of the Red Roads funding. Mr Power confirmed that they presently do not have the allocation for Red Roads, however it is hoped that a draft will be brought before the Members at the April meeting. He confirmed that the issues in relation to the roundabout at Boherclough Street will be referred to Roads Capital Nenagh. In relation to the LIS he confirmed that 20 applications are being considered which includes some applications which were made last year. Mr Tim Kilmartin confirmed that Bishopswood, Dundrum is one area that is being considered under the Red Roads funding. Councillor Moloney requested that Carron, Cashel to Cahir which bounds St Declans Way which was walked on Saturday would be considered for Red Roads.

Due to a recent retirement, the road crossing warden on the Green in Cashel has been vacant since December. This is a health & safety issue for residents in Cashel and students in St. John the Baptist Boys NS, St John the Baptist Girls Primary School and Cashel Deanery School.
