

Management Report to Council

Local Community Development Committee (LCDC)

The LCDC continues to serve to serve as a platform for local community engagement and decision-making in matters related to community development and local services. In 2024, the committee has benefited from presentions on Mens Shed, Age Friendly Homes Programme and the Transport Coordination Unit (Local Link). LCDC member were delighted to particiopate in the launch of LEADER 2024-27 on April 21st last.

Social Inclusion Community Activation Programme (SICAP)

The 2024 Annual SICAP Plans for North and South Tipperary were agreed at the LCDC and both development companies have targets to work with 37 groups (KPI 1) and 485 individuals (KPI 2) in the current year. A mid year review will be conducted in June.



Clár 2024 Funding

The Minister for Rural and Community Development, Heather Humphreys TD, launched the 2024 CLÁR Scheme on Friday 12th April 2024.

Under Measure 1 of the 2024 initiative, grants from €5,000 to €50,000 are being provided to support the development of community and sports facilities, youth clubs, playgrounds, sensory gardens, walking tracks and much more.

Tipperary JPC

At the February meeting Chief Superintendent Aileen Magner reported on the levels and patterns of crime, disorder and anti-social behaviour in the County. Inspector Padraig Sutton delivered a presentation on the Life Saver Project which provides an honest and very powerful look at road safety and the consequences when things go wrong.

Regional Positive Ageing



9th EU Just Transition Platform – Brussels

TCC were represented by Elaine Cullinan (Economic Development Officer) and Clare Lee (Environment and Climate Action Co-ordinator) at the recent Just Transition Platform conference in Brussels.

Just Transition Fund LECP application

A successful application for 'preapprenticeship training and language supports' was made under the Just Transition Fund. Funding of €999,791 was announced in April last for the programme which was led by Tipperary ETB in partnership with Tipperary County Council (ECRD Section).

It aims to address skills gaps and capacity issues across a number of sectors including construction.

RuralBioUp

TCC are working with the Irish Bioeconomy Foundation on the RuralBioUp project, a Horizon Europe funded project aimed at empowering rural regions to adopt biobased solutions.

ABS Building Ballingarrane

(Update May 2024)

A revised Basis of Design and scope of works have been agreed with PRATUM and RPS.

The design team are focusing resources on the planning and design stage of the ABS building, with an anticipated planning application submission in Oct 2024.

Local Enterprise Office

The Local Enterprise Office in Tipperary assisted 38 projects during 2023 which was slightly lower than the 42 targeted coming in to the year. Generally, LEO Tipperary exceeded target metrics agreed with Enterprise Ireland. The net creation of 97 jobs in client companies was the 7th highest in the country.

Continued growth across the engineering, food and construction services sectors is contributing to this strong performance.

The land activation team that is looking at unlocking and making available industrial development land and sites is providing for future growth prospects on the small start up sector, particularly over a 3 to 7 year timeframe.

Tipperary County Council Local Authority Climate Action Plan (LACAP) 2024 – 2029

The LACAP was made on the 12th of February 2024 and sets out how the Council will deliver on climate action (Mitigation and Adaptation) in areas within its own remit and how the Council through its actions, will seek to influence, facilitate and advocate for climate action across other sectors and communities in how they achieve their own climate actions and targets. The LACAP comprises 100 ambitious actions, along with opportunity areas and actions for the Tipperary 'Decarbonising Zone'. There is also a commitment by the Council to participate and lead an outward facing stakeholder group 'SustainableTipp'. The delivery of climate actions as set out in the LACAP has commenced through the Climate Action Office, along with the Council's Climate Action Team.

Community Climate Action Fund

The Community Climate Action Fund application deadline closed on the 27th February, 2024. There was huge interest in the fund and this was evident by the value of the projects seeking funding. Applications received are currently being assessed and it anticipated that approved applications will be known in August 2024.

Funding for 'Biomethane for Carbon and Community' project applicaation in the Tipperary Decarbonising Zone

An application for funding to the sum of €993,011 by TCC as lead authority (through the Environment and Climate Action Section) and partnered by the Technical University of the Shannon (TUS), the Irish Bioeconomy Foundation and the Tipperary Energy Agency under the EU Just Transition Fund Local Authority-led LECP projects was successful and the full amount of funding sought was received.



The 'Biomethane for Carbon and Community (BCC)' concept centres on the National Bioeconomy Campus at Lisheen and the Tipperary Decarbonising Zone (DZ), and will establish a Biomethane Development Office (BDO). This would act as an independent resource to support and enable communities, enterprises and the agriculture sector to develop an economically feasible biomethane concept with decarbonising at its core.

The key impact of the BCC would be to enable the Tipperary DZ, the JTF areas and wider region to be first movers in responding to emerging national policy and supports for biomethane development. It would ensure that local stakeholders are at the forefront of biomethane development (with associated reduced reliance on fossil fuels, a focus on biodiversity, land use diversification and economic benefits in the form of local jobs) and prepare the conditions for future investment and development. Furthermore, by placing the BDO at the same location as the IBF National Bioeconomy Campus, synergies across the Bioeconomy sector can be exploited.

Further details about the Tipperary DZ can be found in the Tipperary Local Authority Climate Action Plan 2024 – 2029.

Policy

The final meeting of the current Environment & Climate Action Strategic Policy Committee took place on the 27th of March at the Horse and Jockey Hotel.

Public Awareness Initiatives

Green Schools

44 schools in Tipperary will be awarded their Green School Flags at an award ceremony in Hotel Kilkenny on 13th May. This year saw 6 schools being awarding their first Green Flag for the 'Litter and Waste' theme.

National Tree Week


1,200 native Tree saplings were distributed to 39 groups in support of National Tree Week. The theme of this year's campaign was "Planting Trees for a Greener future". Trees were provided from the Tree Council of Ireland with the support of Coillte.



Responsible Dog Ownership

A social media campaign continues to urge dog owners to be extra vigilant and keep their dogs under control during lambing season. The campaign highlights that attacks not only cause undue suffering to sheep but have a devasting economical and emotional impacts on farmers. The public are asked to report any incidents of sheep worrying or attacks on livestock to the Council's Dog Warden service or their local Garda Station. In addition the Council is taking part in the Department of Rural and Community Development's national awareness campaign to remind dog owners of their responsibilities. The Section continues to provide signage and stencils to the Municipal Districts for use in dog fouling blackspots. Plans are underway to launch the Green Dog Walkers Programme in the next few weeks.





Tipperary Town Green Hub Initiative

The Tipperary Town Green Hub initiative was officially launched on Tuesday 5th March in Ballykisteen Hotel, Tipperary. The breakfast launch was attended by a number of hospitality businesses from the town and surrounding area where they heard about the initiative and supports available to hospitality businesses to help manage their waste.

National Spring Clean

To date 223 groups and an estimated 6,200 volunteers have registered to take part in clean-ups throughout the County as part of the National Spring Clean. The Section continues to supply clean-up supplies to registered groups and arrange for collection of bags after clean-ups. Registration closed on 30th April 2024.





Wild on Flowers Promotion at Marts

The Wild on Flowers promotion visited the following Farmers Marts where 950 packs of bulbs and 200 boxes of wildflower seeds were distributed to those attending the Marts.

Tipperary Town – 12/04/2024; Nenagh – 16/04/2024; Thurles – 22/04/2024; Cahir – 24/04/2024

The aim is to promote pollination in the countryside by encouraging farmers and community groups to plant areas with wildflowers.

2024 Tidy Town Grants and Burial Ground Maintenance Grant Scheme

Tidy Town Grant and Burial Ground Maintenance Grant Schemes for 2024 have closed for applications to the relevant Municipal Districts and will now be processed for payment by the MDs.

Derelict Sites

There are 76 properties on the Derelict Site Register. To April 2024, the Section engaged with 32 owners in relation to remediating their properties; 2 Section 8(2) Notices (intention to place on Derelict Sites Register) issued and 3 Section 8(7) Notices (placing on the Register) issued.



Veterinary Services

Horses

8 horse queries have been reported to the Section, which resulted in 6 horse pickups as of the 22nd April 2024.

Dogs

A total of 47 dogs were surrendered or seized by the dog wardens to 31st March 2024. The number of dog licenses purchased to 31st March 2024 is 2,276.

Abattoirs

306 visits to abattoirs by veterinary staff for the purposes of food safety inspections have taken place as at 26th April 2024#.

Circular Economy Infrastructure

Civic Amenity Sites



A total of 28,491 customers used the services of the Council's five Civic Amenity Sites to the end of Q1, 2024. The Section, in partnership with Rotary Ireland, are running a Bicycles to Africa project. Members of the public can donate free of charge suitable bicycles at the Sites. These bicycles are then transported to Shelton Abbey, Arklow to be repaired and shipped to Africa to assist students with their daily commute to school.

Burial Grounds

Burial Grounds Capital, Minor and Improvement Works

Burial Grounds Capital, Minor and Improvement Works (including Site Selection) continue at the following locations: Ballina (Boher) - complete, Fethard, Cahir, Solohead/Monard, Carrick-on-Suir, Kilmore, Cloughprior, Killaghy-Mullinahone, Thurles (St Patrick's), Holycross, Kilnarath, Clonmel (St Patrick's), Newcastle, Tyone and Lisbunny Nenagh.



Waste Management and Enforcement

To date, 7 Section 14 Directions (to remediate a site) have issued.

Legal Proceedings

A successful Circuit Court appeal case was heard in February whereby following evidence given by Enforcement Officers, Judge Catherine Staines upheld the District Court convictions of June 2023 for breaches under the Waste Management Act 1996 as amended, in respect of an unauthorised facility in the Thurles MD area. 3 offences were upheld awarding €3,000 penalty per offence; investigative and legal costs were also awarded to the sum of €10,000. The site was also dealt with in the High Court where the operator signed an undertaking to cease the activity and clean the site.

Three cases of unauthorised waste activities were heard in Cashel District Court in March where Judge Brian O'Shea directed that the cases be forwarded to the DPP. An update was given to Judge O'Shea at the same Court on 18th April 2024, where the state solicitor, on behalf of the DPP, made a request for additional time which was needed to prepare the case files. This request was granted and the cases were adjourned to Clonmel Circuit Court on 4th July 2024 for progression by the DPP.

On the 3rd April 2024 a case was heard at Tipperary District Court (which took place at the Courthouse, Nenagh) in relation to illegal dumping activity in Tipperary-Cahir-Cashel MD. Judge Elizabeth MacGrath heard evidence given by the Waste Enforcement Officer and convicted the individual responsible for offences under the Waste Management Act 1996 as amended, imposing penalties of €4,000, legal and investigative costs of €8,000 and six months in prison subject to the site being cleaned by June 2024.

The case will return to the District Court in June 2024 (on a date to be confirmed) where the Waste Enforcement Officer will present evidence in relation to the nature and extent of the cleanup ordered by the Court. It will then be a matter for the District Court to decide whether to impose the custodial sentence handed down at the previous Court hearing.

Fixed Payment Notices (FPNs) Issued

As at 19th April 2024, a total of 45 Fixed Penalty Notices have been issued.



Household Waste Inspections

A total of 138 household waste surveys have been carried out on houses in the county to date in 2024.

Circular Economy Act re. CCTV usage to amend Waste Management Act and Litter Pollution Act

The WERLAs, with the support of a National Working Group, have now developed guidance to assist Local Authorities in the implementation of the Codes of Practice. Each Local Authority is required to have an Oversight Board in place in accordance with the Codes of Practice and the guidance includes template documents that can be adapted to by each Local Authority.

Glass, Cans & Textile Recycling

1,140 tonnes of glass and 32.5 tonnes of cans were collected as at the end of April 2024.

Certificate of Registrations/Waste Permits

There are currently 44 active waste facilities authorised by Tipperay County Council across the county. Data validation of these facilities has commenced for 2024.

Landfills & Waste Removal from Rathcabbin

Ballaghveny landfill

The monitoring of the landfill in compliance with its waste licence conditions is ongoing.

Donohill landfill

The monitoring of the landfill in compliance with its waste license conditions is ongoing.

Rathcabbin Waste Removal

The removal of waste from the former Shannon Vermi-Composting (SVC) facility in Rathcabbin to Ballaghveny landfill continues and is anticipated to be completed by the end of 2024.

Closed landfills

An application for funding was submitted to the Department of Environment, Climate and Communication, for environmental risk assessments and Certificates of Authorisation for closed



landfills within the county at: Tipperary Town; Dundrum; Knocklofty, Kilsheelan; Killeigh and Caherabbey, Cahir; Deansgrove; Cashel; Connawarries, Carrick-On-Suir; Brittasroad and Monanearla, Thurles; Kiltillane, Templemore; Shesheraghscanlon, Borrisokane; Glencrue, Portroe; Grange, Ballina; Bawn and Rathnaleen North, Nenagh; Cooleen, Silvermines.

Environmental monitoring of these historic landfills is ongoing

25 Planning applications have been assessed and reported to the Planning Section to ensure potential environment impacts of proposed developments are identified and mitigated at planning stage.

Air

Inspections in relation to the solid fuel regulations continue.

Rural Water Programme

Multi-Annual Rural Water Programme 2024-2026 projects submitted to the Department of Housing, Local Government and Heritage on 12th April 2024. An update on progress in the Rural Water Programme 2024 will be presented at the next meeting of the Rural Water Monitoring Committee, which is scheduled to take place on the 14th May 2024.

Environmental Complaints

To the end of April, a total of 627 environment complaints were received, 80% of which have been dealt with and closed.

Capital works 2018 - 2023

During the lifecycle of the current Council there has been two multi annual housing programmes which have facilitated the acquisition and construction of social housing in Tipperary.

Rebuilding Ireland ran from 2018 – 2021 and set a target of 625 additional units to be delivered through acquisition, building and leasing.


Over the lifetime of this programme Tipperary County Council delivered a total of 811 units which exceeded the set target by 186 units, or 30%.





Housing For All commenced in 2022 and is a comprehensive housing strategy designed to deliver housing through multiple streams' including social housing construction, affordable housing, Croí Conaithe refurbishment and cost rental units.

Tipperary County Council was set a target of 956 units (887 build units and the balance through Repair and Lease/ RAS type contracts) to be delivered by the end of the programme in 2026. To date this Council has delivered 389 units with a further 794 in the pipeline to be delivered by the end of the programme. Once Housing For All concludes in 2026 this Council will have delivered over 1125 new build units and over 1200 houses in total excluding acquisitions.



During the lifetime of this Council, 2019–2024, the Capital expenditure on acquisition and construction of houses has been almost €197m which reflects the huge investment in housing stock in the county.

Energy Efficiency Works 2018 - 2024

The programme commenced in 2018 with work being completed to approximately 2,000 dwellings. In 2020 Tipperary prepared documentation for Phase 2 of the programme and was successful in receiving €1.63m under the Midlands Retrofit programme with works carried out to 60 houses in Gortnahoe, Templemore, Thurles Templetuohy and Rathcabbin.

Further works were carried out under the Energy Efficiency Retrofit Programme in 2021 and 2022 which included 60 houses located in Littleton, Templemore, Moyne, Templetuohy, Two Mile Borris, Gortnahoe, Roscrea & Borrisoleigh.



RAS Voluntary

There were 100 houses allocated to Tipperary under this scheme in 2022, and 2023 with the majority of these units now complete which included houses located in Cloughjordan, Ballina, Roscrea, Borrisoleigh, Templemore, Thurles, Clonmel Town, Carrick-on-Suir Town, Tipperary Town and Cahir Town.

A further list of units proposed by each Municipal District has been assessed in accordance with the Departments guidelines under criteria to be eligible under the scheme. Tenders are currently being published to perform detailed surveys of the units prior to issue of the construction tender.

Qualifying works under the scheme typically involve insulation, upgrades of windows and doors and installation of heat pumps (renewable energy heating systems) up to a monetary limit set out be the scheme.

Voids 2019-2024

Tipperary has increased its housing stock between 2018 and 2023 from 4927 to 5439. This figure will increase further under the national plan "Housing For All" to 5958 by the end of 2026. This represents an increase of 1031 houses or 20% over an 8 year period.

In 2020 a loan was approved by this Council to address the issue of long-term voids in Tipperary. This along with maximising funding from the Department over these years reduced the percentage of voids in Tipperary from 4.7% to below 2% which is below the national average. This Council has spent a total of €20.5m in the period 2019-2023 to address the issue of long term voids.

There has also been a consistent reduction in the turnaround time from the time a house is made vacant to when it is brought back into use; from a highpoint in 2021 of 43.6 weeks down to 34 weeks in 2023. The current phase will see the downward trend in turnaround times continue as the time taken to bring houses back into circulation reduces

There are currently 31 live NTQ cases (i.e. whose NTQ comes into effect in 2024) actively engaging with the Council's NTQ team regarding potential property acquisition or to source alternative accommodation.

We have also introduced a Mental Health OFD project in conjunction with HSE Mental Health Service which has seen 5 units of emergency



accommodation provided county wide targeting individuals with enduring mental health illness.

In response to reports of rough sleeping in the Clonmel area, an emergency bed unit was established in late 2023. Initially, this was funded as a cold weather initiative however due to the need, an application for funding has been submitted to the Dept to make the service permanent. Capacity has recently been increased to 14 beds.

Homeless Update 2019-2024

Tipperary County Council's Homeless team has seen significant expansion and progression over the past 5 years.

In 2019, the team consisted of one Homeless Prevention Officer, one Resettlement Officer and one HAP Placefinder. This has increased in the intervening period to:

- two Homeless Prevention Officers,
- two HAP Placefinder workers,
- a Resettlement & Outreach worker,
- Homeless Coordinator, and
- two clerical support staff.

The table below provides an overview of the number of homeless clients who were successfully tenanted since 2019 – note this excludes the 141 properties which were purchased since 2022 under the Tenant In Situ Scheme and where NTQs were received by families

In terms of emergency accommodation, in 2019 Tipperary County Council utilised private B&B providers as the primary source of emergency accommodation. Between 2019 and 2024, Tipperary County Council has moved to the Own Front Door (OFD) model in collaboration with AHB's which has reduced reliance on B&B emergency accommodation. OFD is now the primary response to individuals and families presenting as homeless.

Housing First (HF) was introduced in South Tipperary in 2018 with a case load of 12 supported by 1 project worker. This project has been expanded county-wide with a target of 32 units by 2026, supported by 3 project workers. There are currently 21 individuals housed under the HF project.

The Housing First Team has recently expanded to include much needed HSE supports and Members support in this area was valuable. Clients accessing the service across the county now have access to Clinical Psychology and nursing supports along with Occupational Therapy supports in the North.

Our Tenancy Sustainment Service has doubled its capacity since 2019, with the addition of a second project worker based in the two northern Districts.

Expenditure for homeless supports has increased and become more targeted over the period:

During the period 2019-2023, Tipperary County Council have spent over €11m between the construction, maintenance and improvement of traveller specific accommodation.

Ukrainian Refugees

Tipperary County Council continues, in partnership with Local Development Companies and community groups, to facilitate the provision of accommodation and integration support services to Beneficiaries of Temporary Protection (BOTPs). As a result of policy and legislative changes, the two emergency rest centres in Littleton and Clonmel have closed and the emphasis of the Ukrainian Response Team now is on providing support for the BOTPs in securing accommodation through pledged accommodation and the Refurbishment Programme in addition to integration services.



Emergency Rest Centres

The two rest centres provided emergency accommodation over the past 22 months for those fleeing the crisis in their homeland and proved very successful until their closure in March 2024

- Provided accommodation for 1810 BOTPs
- 91 separate intakes
- 42,231 bed nights
- 126,693 meals served
- 51% of residents secured more permanent type accommodation within the county

Pledged Accommodation

- IRC Pledged Properties TCC supported IRC to accommodate 231
 Ukrainians in both vacant and shared units.
- Offer a Home Pledged Property: To date the Council has facilitated the provision of 678 Ukrainians with housing in 193 properties.

Commercial Operators

 There are 28 commercial operators in the county with a capacity for some 1200 BOTPs

Refurbishment Programme

The Council provides support to both the Department of Housing and DCEDIY to deliver properties which can be refurbished to accommodate BOTPs. Set out below is the current position under this programme:

- Church Street, Cahir- 16 beds- operational
- Airmount House, Tipperary 26 beds- contract signed with go live date of 26/03/2024
- Bank of Ireland, The Square, Cahir- Phase 1 20 beds, contract signed with go live date of 03/04/2024, Phase 2, 6 beds – construction stage
- Ballycormuck House, Aglish, 22 beds Contract Signed and go live date of 25/04/2024



 Stonehouse, Clonmel 25 beds–Documentation and plans with Department for their decision

Modular Homes

- 62 modular homes have been provided by the Department at Gortataggart, Thurles with 248 BOTPs accommodated.
- A site in Clonmel is currently under consideration by the Department to provide 82 homes at Haywood Road with accommodation for 328 BOTPs.

Community Integration

The Council continues to work closely with other agencies such as the H.S.E., Department of Social Protection, AGS, Education, Local Development Companies etc in assisting the families accommodated to integrate with the local communities and to access the necessary health, educational, income and other supports.

Given the reduction in BOTPs into the country, the Ukrainian team has now moved to C&E Section under the LAIT and will be reported from hereonin under the C&E report.

SHIP Renewal

The SHIP Renewal, similar to the Buy and Renew scheme is designed to support local authorities (and approved housing bodies) to purchase and renew vacant housing units in need of remediation and make them available for social housing. SHIP Renewal is aimed at much larger scope of works from the Buy & Renew Scheme, and is utilised when the purpose is to deep retrofit a property and bring it up to a very high modern standard. 5 Properties were delivered under this scheme in 2023, with 6 in the pipeline for delivery in 2024.

Repair and Lease

The Repair and Lease Scheme, a companion strategy of the Buy and Renew scheme, has a financial incentive of €80,000 to encourage developers to participate in the scheme in the interests of delivering long term social housing supports for properties which have bene left vacant/derelict or underused.

19 Units were delivered under the scheme in 2024, located in Nenagh, Thurles and Clonmel. A target of 18 units has been set for 2024 with a planned pipeline of units in Carrick-on-Suir, Clonmel, Tipperary Town and Nenagh currently at various stages of agreement and construction. Further proposals across the county are currently being reviewed. These



units tend to be apartments as opposed to dwellings and are typically located in the towns.

Affordable Housing

There are a number of key pathways under the Affordable Housing delivery mechanism which are being pursued by Tipperary County Council to ensure that as wide a population as is possible can benefit from the strategy. These include a) Croí Cónaithe Scheme; b) The First Home Scheme; c) Ready to Build Scheme; d) Affordable delivery through turnkey; e) affordable delivery through LA or AHB Build; f) Tenant Purchase Scheme and g) the Local Authority Home Loan Scheme

The Council is already active in the area of Tenant Purchase; Local Authority Home Loans; and the Croí Cónaithe Scheme.

Affordable self Build: - The Council has progressed with the sale of 4 self-build affordable sites in Boherlahan. We have received c 18 applications for purchase under the call and the successful applicants have been ranked by order of priority as per the requirements of the scheme. A draw for the sites will be made at the May council meeting for the successful applicants and we will then proceed to engage with the top 4 applicants in terms of progressing with their plans.

It is also proposed to offer affordable homes for sale to those applicants who qualify for the Affordable Housing scheme, subject to access to the Affordable Housing Fund. A call has been made for expressions of interest in the Clonmel area from those developers who have an interest in providing affordable homes and who already have planning permission. Following receipt of interest from this call, an application will be made to the Department to access the AHF fund and a priority list of interested purchasers will be formed. It is hoped that such a process will also give a much needed boost to deliver additional private housing units.
