5.1 Cllr. Marie Murphy & Cllr. Michael Anglim (Ref. 2010)

That this Municipal District would invest in a new road sweeper for the Cahir Electoral Area to service not just the town of Cahir, but the surrounding villages of Ardfinnan, Ballylooby,

Ballyporeen, Burncourt, Clogheen, Goatenbridge, Grange, Newcastle, New Inn and Skeheenarinky.

5.2 Cllr. Andy Moloney (Ref. 2017)

That the TII provide details of the amount of times they have repaired crash barriers and attended to the road surface at Knockagh Roundabout since 2018 and that they fulfill their commitments to renew the anti-skid surface given at that time as this roundabout and the approach to Knockagh has become a black spot for motorists.

5.3 Cllr. Marie Murphy (Ref. 2014)

That this Municipal District would contact Irish Water to get them to resolve the ongoing issues with the drains/culverts at Madden's Lane, Cahir. This drain/culvert gets blocked on a regular basis and the recent blockage resulted in a horrendous smell throughout the Church Street and Square areas.

5.4 Cllr. Andy Moloney (Ref. 2015)

That this Council explore the cost of a CCTV system for Cahir Town Centre and link it in as part of any future public realm improvements for the town.

5.5 Cllr. Mairin McGrath (Ref.2025)

That this Council would carry out works to extend the footpath and provide public lighting on the Cashel Road, Cahir beyond the junction for Barnora and Colaiste Dun lascaigh as far as the speed limit change at the old bakery.

5.6 Cllr. Mairin McGrath (Ref.2026)

That this Council would carry out footpath repair works on upper Main Street Ballyporeen, extend the footpath on the Clogheen Road, Ballyporeen towards the speed limits and develop a footpath leading to Happy Days Crèche within Cois na hAbhainn estate.
