5.1 Councillor Marie Murphy (Ref ID 1021)

That Irish Water or this council would rectify, for once and for all, the recurring sewage blockage issues affecting the majority of houses at Lios Mhuire, Clogheen. This problem has been ongoing for over 30 years and is getting continually worse.

5.2 Councillor Marie Murphy (Ref ID 1022)

That Irish Water or this Council would rectify, the recurring sewage blockage issues at Maddens Lane, Cahir. I believe that this lane is public and that the council did replace some pipe work a number of years back.

5.3 Councillor Andy Moloney (Ref ID 1044)

That this council call on Minister Finian McGrath to provide full time respite in Brothers of Charity centres in Clonmel.

5.4 Councillor Richie Molloy (Ref ID 1045)

That Clonmel Borough Council would consider employing staff to maintain the grass cutting in St Patrick's Cemetery during the summer months and also to note that visitors to the cemetery are very concerned at the condition of the cemetery.

The bridge in question is an important part of the St Declan's Way/Munster Way Walk, contains a mains water pipe supplying a vast area and is currently in bad repair.

- CCTV in Elm Park & Coolcen's Close - Paul Murray, District Administrator confirmed that the appointed consultants had provided their report and that tender

documents would now be prepared. It is hoped that CCTV would be operational at both locations by the end of summer 2017;

- Traffic Calming at Marfield Lake – speed surveys were carried out, which showed that traffic calming measures already in place at the lake were sufficient. New signage will be erected;
- Clonmel Arms Hotel – Mr Paul Murray confirmed that the new owners were a private group who were keen to develop the site, exploring all options available to them. He further confirmed that it had been arranged that the council's Conservation Officer would carry out an inspection of the site and report back in due course;
- Marfield Flood Scheme – tender documents are nearing completion;
- St Patricks Cemetery – works to commence, funding has been finalised and agreed with the Environment Directorate. Tender process to commence. Hoped to have a contractor on site within 4 weeks;
- Clonmel to Carrick on Suir Greenway – maintenance costs to be finalised. Project is 90% complete, as per report of Project Manager.

Section 2 works in Kilsheelan are hoped to be completed by June 2017.

With regard to horse fouling on the Greenway, the people involved have been contacted and have committed to keeping the area clean.

The situation will be reviewed on an on-going basis.

- Illegal Dumping Heywood Road – clean up has commenced. Housing Directorate to write to all residents and inform them of their obligations. Environment Directorate to install covert camera's to detect illegal dumping. In the long term, a plan is to be developed involving multiple agencies.

5.1 Councillor Pat English**No. 989**

That Clonmel Borough District removes the dangerous step in the roadside wall at Ballyvaheen, Ballyclerihan on the R688, the existing road carriageway is very narrow and a serious health risk to the people who use the road.

Reply

Road realignment was proposed here in 2005 but agreement with the landowners involved was not forthcoming at that time. The wall is the responsibility of the landowner and any works to same would need to be discussed with them. The Area Engineer will examine the location and identify potential solutions.

5.2 Councillor Pat English**No. 990**

That Clonmel Borough District provide bollards at either side of the entrance to Ashbourn House on the Mountain Road, R678 to provide a safe exit for the residents of Ashbourn House. Parents who collect their children from the Loreto Convent park on the footpath along the Mountain Road.

Reply

Two bollards are to be installed as per the instruction of the Area Engineer.

The New Inn Road Roundabout means nothing as there is a New Inn Road Roundabout in the Center of New Inn that's confusing.

That Clonmel Borough District would repair/replace the flashing warning lights adjacent to St Mary's National School, Clogheen, as a matter of urgency.

Reply

These lights have electrical issues, an application for funding under the Clár 2017 Grant to replace them (Department of Arts, Heritage, Regional, Rural and Gaeltacht Affairs) will be considered.

5.8 Councillor Martin Lonergan

No. 1024

That Clonmel Borough District, remove the junction (Cahir Side Grange Village) with the L3512-2 (Graveyard Rd) Road and the L3511-0 Road (Ballindoney West Rd) in the urgent interest of Road and Pedestrian Safety. For cars exiting from the Cemetery Road, L3512-2, the sightlines to the left are non-existent.

Reply

Sightlines are poor at this junction and there will be a need to remove the existing sod and stone fence in order to improve intervisibility, the fence is in the ownership of a private landowner. If the landowner was willing to work with the Council then a design could be prepared and costed and an application made for funding under the 2018 Low Cost Safety scheme.

RE: Taking in Charge of Estates / Declaration of Roads to be Public Roads.

Introduction

Substantial work is being done by this Local Authority to ensure that estates are taken in charge by the Authority. Given the high rate of completions of houses in recent years, this work has taken on an even greater importance and will continue to do so for the foreseeable future.

Legislative Background

Section 180 of the Planning and Development Act 2000 as amended, places a legal obligation on local authorities to take in charge housing estates, where certain conditions have been met. The process for initiating the legal procedure is under Section 11 of the Roads Act, 1993.

- **Ashfield Manor, Ardfinnan**
- **Monroe, Lisronagh**

Where an order is made under Section 11(1) of the Roads Act, 1993, in compliance with this section, the planning authority shall, in addition to the provisions of that section, take in charge any open spaces, car parks, sewers and water mains within the attendant grounds of the development.

Public Consultation Process

The procedure under Section 11 of the Roads Act 1993 was initiated on 23rd February 2017 by the publication of a newspaper notice advising that it was proposed to declare the roads in the estates listed below to be public roads.

Maps showing the roads to be declared public were put on display for a period of one month and objections or representations in relation to the declaration were invited on or before 19 April 2017.

No objections or representations in respect of these housing estates were received during the consultation period.

Financial Implications

It is considered prudent to advise the members of the financial implications of taking the estates listed below in charge:

- **Ashfield Manor, Ardfinnan**- There are potential outstanding works in the amount of €148,500.00, (€138,500.00 for Roads and €10,000.00 for Water Services). A Bond in the sum of €137,637.50 was received by Tipperary County Council. There is also €5,000.00 Department of Environment, Community & Local Government (DECLG) funding available.
- **Monroe, Lisronagh**- There are potential outstanding works in the amount of €7,450 excluding VAT.

Recommendation

I recommend, therefore, that the roads serving the housing estates known as:

1. **Ashfield Manor, Ardfinnan**
2. **Monroe, Lisronagh**

be declared public roads and that the open spaces, car parks, sewers and water mains within the developments be taken in charge by this Municipal District.
