That Clonmel Borough District would erect a wall or fence at open space between Glenoaks Close, Glenconnor, Clonmel and the Borough District

lands adjoining, to stop the ongoing anti-social behaviour in the area.

7.2 Councillor Michael Murphy (Ref ID 1213)

That under the 2018 Area Roadwork's Programme for the Clonmel Borough District that consideration is given to creating a small number of public parking spaces in the Fairfields Estate within the green area adjacent to house number 38 and others.

7.3 Councillor Michael Murphy (Ref ID 1214)

Following on from partial resurfacing of the estate in recent years, that under the 2018 Area Roadwork's Programme for the Clonmel Borough District that consideration is given to the resurfacing of the remainder of the Ballingarrane Estate, (house numbers 1 - 28), taking into account its very poor condition.

7.4 Councillor Pat English (Ref ID 1215)

That Clonmel Borough District resurfaces the damaged section of roadway in Ballingarrane, Cahir Road, Clonmel in the 2018 Road Works Programme.

7.6 Councillor Siobhán Ambrose (Ref ID 1217)

That Clonmel Borough District Council renews it's efforts to make contact with the owner of the lands beside St. Patrick's Well with a view to examining the possibility of providing a much needed car park for visitors to the well. In particular this proposed car park would enable persons in wheelchairs and other persons with a disability access to St. Patrick's Well which is currently not accessible to them due to the large number of steps at the entrance to the Well- (ref my previous motion on this issue).

7.7 Councillor Siobhán Ambrose (Ref ID 1218)

In the interest of safety that Clonmel Borough District Council requests Transport Infrastructure Ireland (formally the N.R.A.) to look at inserting an additional pedestrian crossing on the main N24 in Kilsheelan village at the section of the road that divides the Forest View / Ivowen estates (on one side of the road) and the Garden Grove estate (on the other side) in order to make it safer for residents in particular children to cross safely at this section of the road.

7.8 Councillor Siobhán Ambrose (Ref ID 1219)

In the interest of safety that Clonmel Borough District Councils looks at improving the surface of sections of the Fr. Matthew Terrace/ O' Rahilly Avenue roadway which should include the insertion of some type of traffic calming measure.

Item 1.1 - Minutes

The minutes of the monthly meeting of Clonmel Borough District held on the 20th September 2017 were proposed by Councillor Siobhan Ambrose, seconded by Councillor Micháel Anglim, and agreed.

Item 2.1 — Attendance of the Planning Directorate

Mr Brian Beck, Senior Planner, circulated a District Briefing note to Members detailing key issues relating to the Planning Directorate under the following headings-

- 1. National Planning Framework Ireland 2040: Our Plan;
- 2. Regional and Spatial Economic Strategies;
- 3. National Policy Statement on Bio-Economy;
- 4. Cluster Guidelines;
- 5. Built Heritage Scheme;
- 6. Taking in Charge;
- 7. Number of Planning Applications received in 2016/2017;
- 8. Enforcement Proceedings in 2017;

Members noted their agreement with the change in structure of Pre-planning meetings to address the waiting list for preplanning appointments.

A proposal to bring the Masterplan for Mick Delahunty Square to public viewing was proposed by Councillor Pat English, seconded by Councillor Andy Moloney and agreed.

The Deputy Mayor Councillor Richie Molloy thanked staff from the Planning Directorate for their attendance and report.

Item 3.1 – General Municipal Allocation (GMA) 2018

Mr Liam McCarthy, Head of Finance set out the 2018 General Municipal Allocation (GMA) to Members.

Mr McCarthy outlined that the GMA for 2018 was €1,091,455.00, comprising of €591,455 arising from the decision to increase the Local Property Tax at the September meeting of Tipperary County Council and €500,000 of an allocation similar to 2017.

Liam McCarthy explained that the GMA is allocated to Municipal Districts based on population according to the 2016 Census.

The 2018 allocation for Clonmel Borough District is therefore €251,670.

The following queries were raised by Members:

- More transparency was called for with regard to rates and parking charges revenues generated by individual Municipal Districts; Can a breakdown of individual Municipal District revenues be provided to Members;
- Will the GMA be used for items such as Blueway maintenance;
- Is the extra funding in the GMA allocation only for one year, will the allocation revert to 2017 figures in 2019:
- Some Members pointed out that the Local Property Tax only needed to be increased due to a cut in funding from Central Government.

Members queries were responded to and agreed as follows:

- Liam McCarthy will revert to Members with a breakdown of Rates revenues in Clonmel Municipal District;
- Liam McCarthy confirmed that the Local Property Tax increase was only for 2018 and the allocation will revert to 2017 figures in 2019:
- Liam McCarthy also stated that calculating the GMA allocation based on the population census was the fairest method:
- Liam McCarthy asked Members that when deciding on projects for the 2018 GMA, they consider one off projects that do not require recurrent spending;
- Liam McCarthy confirmed that the Schedule of Municipal District Works would be presented to Members at the CBD February meeting, after the 2018 Roads allocation was agreed;

The proposed allocation of the GMA for Clonmel Borough District was proposed by Councillor Siobhan Ambrose, seconded by Michael Anglim and agreed.

<u>Item 4.1 – Draft Suir</u> <u>Island Masterplan</u>

The Draft Suir Island Masterplan was presented to Members by Mr Kenneth Hennessy of Kenneth Hennessy Architects.

Mr Hennessy informed Members that a public meeting to present the Draft Suir Island Masterplan would be held in the Main Guard, Clonmel on the 25th October 2017.

The following queries were raised by Members:

- A lack of green areas on the plans for Suir Island carpark was noted by Members;
- Members welcomed the news that the new owner of the Clonmel Arms Hotel site was invited to make comments on the Suir Island development;
- Tipperary County Council should be updated with information on the public meeting;
- Is it possible for members of the public to make submissions on the Draft Suir Island Masterplan at the public meeting;
- Will the proposed bridge, linking Suir Island with the centre of the town, be open 24 hours a day;

Members queries were responded to and agreed as follows:

- Proposals for Suir Island carpark include green areas and the carpark has been designed to be a multi-use space;
- Advert for the public meeting has been placed in a local newspaper, on the Tipperary Co Co website and social media outlets and was emailed to all stakeholders;
- Members of the public will be invited to make observations/comments at the public meeting;
- With regard to the proposed bridge, Kenneth Hennessy confirmed that nothing would be designed that could not be closed.

Ms Sinead Carr stated that it was important to have the Masterplan agreed and in place so that when funding opportunities became available Tipperary County Council is ready to proceed with the application process.

- Is funding available for community groups to develop their areas under the Munster Vales package;

Members queries were responded to and agreed as follows:

- Ms Sinead Carr explained to Members that certain areas
 within Irelands Ancient East are not significant enough
 on their own to make an impact under Irelands Ancient
 East. By coming together the Munster Vales package is
 significant to make an impact under Irelands Ancient
 East.
- Ms Triona Mccarthy confirmed that St Declans Way will be part of the Munster Vales package when it is launched and becomes an approved trail.
- Ms Sinead Carr informed Members that the Munster Vales team have linked in with community groups to access funds under the REDZ programme. Community groups will be advised of future funding opportunities.

Eamon Lonergan spoke of the importance of logging all calls regarding emergencies through the Customer Relations Management system (CRM), so that calls can be accounted for and reported on for recoupment purposes.

Mr Lonergan also told of the importance for landowners and property owners in checking their properties and boundaries with public roads for loose materials and branches.

In the interest of Health & Safety, that Clonmel Borough District would provide a footpath from the housing estate at Derravoher, Ballylooby to link in with the church and school.

The length of footpath required to link the housing development at Derravoher, Ballylooby to the village centre is approximately 450 metres. The estimated cost of construction is €32,000. There are a number of locations along the proposed footpath where agreement will be required from the adjoining landowner to setback roadside ditches and a gateway to accommodate the footpath. Funding for these footpath works is not available this year. However, it will be given consideration under the multi-year Capital Plan.

That Clonmel Borough District of Tipperary County Council would upgrade all old Son / Sox Lights to the much more efficient LED lights in Clogheen, Ballyporeen, Burncourt and Ballylooby.

Reply

Tipperary County Council have committed to upgrading 26 lights on Main Street, Ballyporeen and 24 lights on Main Street, Clogheen from Old Son / Sox lights to more efficient LED lights.

Potential upgrades of Burncourt and Ballylooby are under consideration and Members will be advised in due course of a decision on same.

The lighting schemes are Rathkeevan, Frank Drohan Road and Moangarriff are 100% funded by TII.

That Clonmel Borough Council provide a dog fouling sign on the green area at the side of the old shop opposite Mountain View, Elm Park, Clonmel.

Reply

This sign was erected as there was an existing pole in place and given that we had a sign in stock. The use of signs or stencils to prevent dog fouling is limited and the erection of signs in particular is costly thus giving no value. Dog Fouling should be dealt with under the Litter Pollution Act to create a real deterrent and change in behaviour.

Reply

This will be inspected by the Town Engineer and surveys conducted as required before any calming measures are designed. Surveys planned to be done in early 2018.

7.11 Councillor Siobhan Ambrose

No. 1188

That Clonmel Borough District investigates as to whether it is possible that similar to the proposed traffic calming works on Prior Park Road that similar works be carried out on the road through Marifield Village.

Reply

It is planned to review the traffic situation in Marlfield in 2017 to determine the nature of the complaints on speeding i.e. speed surveys and volume surveys. If it is found that a speeding and safety issue exists, then appropriate traffic calming measures will then be designed, with a preference for horizontal traffic calming by means of reducing the available road width over vertical (i.e. speed bumps/cushions).

It is planned to install Driver Feedback Signs (DFS) in Lisronagh as part of the District Service Enhancement Scheme in 2018. In the interest of Health & Safety that Clonmel Borough District would provide a footpath from the St Mary's National school, Clogheen to the Forestry entrance to the South at Mount Anglesby. This would facilitate walkers to access the many looped walks in the area.

The distance between St. Mary's School and the forestry entrance is approximately 500 metres. The estimated cost of construction for the footpath is €40,000. Funding is not available this year. But it will be give consideration under the Multi-Year Capital Plan.

This motion was proposed by Councillor Marie Murphy, seconded by Councillor Michael Murphy and agreed.
